I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Sri Sunil Kumar Sahu, son of Late Pashupati Sahu, vill- Joshpur, P.O.- Kumra, P.S.- Bundwan, Dist- Purulia was enjoying electricity dishonestly by means of direct hooking from LT line and has committed theft of electricity U/S 135/ 1/a of The Electricity Act 2003.

On 17/08/2023 at about 16:10 Hrs. I, SRI PRASHANTA MANDAL, AE&SM, Bundwan CCC, WBSEDCL.

Along with:

1) Sri Maruti Mahato, Junior Engineer, Gr-I, Bundwan CCC, WBSEDCL

2) Sri Anindya Sundar Paul, Office Executive, Bundwan CCC, WBSEDCL

visited the premises of Sri Sunil Kumar Sahu, son of Late Pashupati Sahu, vill- Joshpur, P.O.- Kumra, P.S.- Bundwan, Dist- Purulia and inspected his premises. During inspection theft of electricity was detected i.e. he was using electricity dishonestly by means of direct hooking.

From the above arrangement he was using the following electrical equipment's:

- 1) 2 Nos of TV
- 2) 9 Nos of fan
- 3) 6 Nos of light and
- 4) 1 No of water pump

Out of which I seized the following:

- 1) 6 mm service cable approx. length 19 m with switchboard.

A seizure list was prepared at the site and the accused person has signed.

The inspection team left the premises at 16:55 hrs. on 17/08/2023.

The accused person has committed an offence U/S 135/ 1/a of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
