Sub: Complaint.

Sir,

In producing here with one arrested accused person namely Bhajahari Mahato (60 yrs) S/o Lt. Akshay Mahato of Vill-Bankati, PS-Barabazar, Dist-Purulia along with Memo of arrest, Seizure List and seized article One Plastic Jarakin containing approx 12 (twelve) liters of I.D liquors (Cholai) and taken 500 ml ID Liquor (Cholai) as sample.

I, SI Nimai Ch. Nemo of Barabazar PS do here by lodge this complaint against Bhajahari Mahato (60 yrs) S/o Lt. Akshay Mahato of Vill-Bankati, PS-Barabazar, Dist-Purulia that on today (14.08.2023) during my evening mobile duty vide Barabazar PS GDE No- 826 Dtd. 14.08.2023 and C.C. NO. 4127/2023 Dt. 14.08.2023 received a source information that one person unauthorized selling I.D liquor (Cholai) at Bankati village under Barabazar PS, Dist- Purulia. I have been then verified the credibility of that information and as per direction of I.C Barabazar PS myself along with force had been to Bankati village to work out the information. At about 21:15 hrs found one person was selling I.D liquor (Cholai). When we reached in front the house of alleged person at Bankati village, then seeing the Police party, customers were fled away. During search with the help of my accompanying force, we found that the said person is stocking Plastic Jarakin containing approx 12 (twelve) liters of I.D liquors (Cholai) and selling from his house. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of I.D liquors. On being asked he confessed his guilt and stated that he selling the ID liquors (Cholai) with intent to sell to make own profit. He disclosed his identity as A Bhajahari Mahato (60 yrs) S/o Lt. Akshay Mahato of Vill-Bankati, PS-Barabazar, Dist-Purulia. He also admitted that he had no license or any authorization to carrying and selling of ID Liquor. Accordingly, I seized the above noted article after preparing a proper seizure list and put label on the seized article in presence of witnesses and 500 ml of I.D liquor (Cholai) taken as sample from that seizure as sample which was also duly labeled and also took signature of the accompanying witnesses as well as accused person on seizure list and label also. The seizure and label was done in between 21:35 hrs to 21:45 hrs

Thereafter, I secured arrest of the accused Bhajahari Mahato (60 yrs) S/o Lt. Akshay Mahato of Vill-Bankati, PS-Barabazar, Dist-Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guide line. Informed him and his relatives regarding the ground of arrest. The arrest was made on 14.08.2023 at 21:55 hrs.

Under the above fact & circumstances I, therefore, pray before you that a specific case may kindly be registered against Bhajahari Mahato (60 yrs) S/o Lt. Akshay Mahato of Vill-Bankati, PS-Barabazar, Dist-Purulia and also for arranging for its investigation.
