**Subject:** Complaint against Shripati Tudu (48 Yrs), S/O- Lt. Nanda Tudu of Vill- Khariduara (Bhurudanga) PS - Boro, Dist - Purulia to start a case with proper section of law.

Respected Sir,

In producing herewith one arrested accused person Shripati Tudu (48 Yrs), S/O- Lt. Nanda Tudu of Vill- Khariduara (Bhurudanga), PS - Boro, Dist - Purulia with one blue colour jerkin loaded with approx 15(Fifteen) ltrs ID Liquor and 01 (one) plastic bottle loaded with 01 ltr ID Liquor from there seized as sample as sell proceed from the possession of above noted accused which were seized under proper seizure list.

I beg to submit that today 02.08.2023 during my evening mobile duty in between 18:35 hrs. to 19:15 hrs. acting on secret source information I apprehended the above noted person in his house at Khariduara (Bhurudanga) village and found that above noted person illegally stocked and selling "ID Liquor" to local public. On interrogation he disclosed his name and address as noted above. On demand he failed to produce any valid documents in respect of stocking and selling said Liquor in his house. Accordingly I seized approx 15(Fifteen) ltrs ID Liquor and a sample ID Liquor of approx 01 Ltr. is taken out in 01(one) plastic bottle as sample from there as sell proceed under proper seizure list in presence of witnesses, which is enclosed herewith. As such he was arrested at 19:15 hrs. u/s 67 B.E. Act. and during arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to the arrestee.

The above noted arrested accused Shripati Tudu (48 Yrs), S/O- Lt. Nanda Tudu of Vill- Khariduara (Bhurudanga), PS - Boro, Dist - Purulia committed an offence U/S- 46A(c) B.E. Act. 1909 for unauthorized possession and selling ID Liquor from his sole possession in his own house.

It may note here that during raid (1) C/ 1204 Bolzar Seikh, (2) C/ 2865 Lalmohan Sardar accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Shripati Tudu (48 Yrs), S/O- Lt. Nanda Tudu of Vill- Khariduara (Bhurudanga), PS - Boro, Dist - Purulia
