**Subject:** Complaint against Monoranjan Tudu (45 Yrs), S/O- Lt. Haripada Tudu of Vill- Mukundapur, PS - Boro, Dist - Purulia to start a case with proper section of law.

Respected Sir,

In producing herewith one arrested accused person Monoranjan Tudu (45 Yrs), S/O- Lt. Haripada Tudu of Vill- Mukundapur, PS - Boro, Dist - Purulia with i) one white colour jerkin loaded with approx 10 (Ten) ltrs ID Liquor and 01 (one) plastic bottle loaded with 01 ltr ID Liquor from there ii) 08 (Eight) sealed bottles are containing 600 ml country spirit in each bottle styled as "DIL KHUSH" and 01 (one) bottle seized as sample from there as sell proceed from the possession of above noted accused which were seized under proper seizure list.

I beg to submit that today 02.08.2023 during my Spl. mobile duty in between 19:05 hrs to 19.45 hrs acting on secret source information I apprehended the above noted person in his house at Mukundapur village and found that above noted person illegally stocked and selling "ID Liquor" & "DIL KHUSH" to local public. On interrogation he disclosed his name and address as noted above. On demand he failed to produce any valid documents in respect of stocking and selling said Liquor & "DIL KHUSH" in his house. Accordingly I seized approx 10(Ten) ltrs ID Liquor and a sample ID Liquor of approx 01 Ltr. is taken out in 01(one) plastic bottle as sample from there and 08 (Eight) sealed bottles are containing 600 ml country spirit in each bottle styled as "DIL KHUSH" and 01 (one) bottle seized as sample from there as sell proceed under proper seizure list in presence of witnesses, which is enclosed herewith. As such he was arrested at 19.45 hrs u/s 67 B.E. Act. and during arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to the arrestee.

The above noted arrested accd. Monoranjan Tudu (45 Yrs), S/O- Lt. Haripada Tudu of Vill- Mukundapur, PS - Boro, Dist - Purulia committed an offence U/S- 46A(c) B.E. Act. 1909 for unauthorized and selling ID Liquor from his sole possession in his own house.

It may note here that during raid (1) C/ 1382 Deb Kumar De, (2) C/ 109 Indranath Hembram accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Monoranjan Tudu (45 Yrs), S/O- Lt. Haripada Tudu of Vill- Mukundapur, PS - Boro, Dist - Purulia
