I do here by bring under arrest accused person namely Amitlal Mahato (32) S/o- Satyakinkar Mahato of Vill- Susunia, P.S. Boro, Dist- Purulia and lodging suo-moto written complain against him. The fact of the case in brief is that today i.e. on 18.08.2023 at about 21:30 hrs., I SI Rana Bhakat; O/C Boro PS and SI Santosh Roy; In-Charge of Jamtoria I/C under Boro PS were returning from Tamna PS through SH-05 after performed some official work (This refers to Boro PS GDE No- 574 Dtd- 18.08.2023). At that time near Susunia mor on SH-05 in between Boro & Manbazar, we noticed that one person have obstructed the said road by lying in the middle position. The place was too much darky and drizzling rain was falling. In this situation, there was every possibility that he may be run over by any vehicle. Accordingly, I approach to him and request him after disclosing my identity to stand off by the side of the road. But, he became violent all of a sudden and assaults me by continuous fist & blows. As a result, I received severe injury on my person. Initially, SI Santosh Roy was monitoring the traffic flow with the help of a torch light. So that, no untoward incident can took place. Seeing that situation, he rush to the spot and tried to rescue me from his clutch. Then, Amitlal Mahato became violent again upon SI Santosh Roy and started to assault him with fist & blows. He also received severe injury on his person. The accused person was also using filthy languages against us. At that time, he was going out of control. Then, I called SI Malay Mishra who was performing evening patrolling duty (vide Boro PS GDE No 578 Date-18.08.2023 and CC No- 3096 Dtd-18.08.2023) to assist us. Within a few minutes, he came to the spot and anyhow brings him manage to under control. Accordingly, I asked him to disclose his identity. At first, he was not agreed to disclose his identity. Lastly, he confirmed his identity as noted above. Accordingly, I arrest him as he committed cognizable offence in presence of a Police officer.

Both of us have been treated at Bari BPHC.

The above noted arrested accused person willfully not only obstructs any public servant in the discharge of his public functions, he also assaults us by using criminal force which caused severe injury to deter public servant from discharge of their duty. SH-05 road was also blocked by him for a while.

Hence I do here by started suo-moto Boro PS Case No 39/2023 Dtd- 18.08.2023 U/s-186/332/333/353 IPC &18 of the West Bengal Highway Act-1964 against arrested accused person namely Amitlal Mahato (32) S/o- Satyakinkar Mahato of Vill- Susunia P.S. Boro, Dist- Purulia after returning to PS.
