Sir,

Most respectfully the undersigned want to inform you that on 28/08/2023 at about 02:00 PM, I was discharging my office duties in my office-chamber, i.e. office of the BLELRD, Hura. So many people were in a long queue for getting Public Service. Suddenly, one woman along with her husband and daughter entered in my chamber and started shouting using abusive languages without detailing any specific complaint. Initially, I was failed to understand the matter and then asked her to describe the matter properly, otherwise it might be difficult to solve the matter. But, she refused to do so and arrogantly threatened me saying that "Bharat Par (to) or Jhingrey (to)" and others started shouting using abusive languages against me and office. During this incident one of my Revenue Officers came to the place and suddenly husband of the said lady assaulted him physically by holding his shirt and grabbed his neck. As a result, the said Revenue Officer was injured at his right side of neck and he was treated in the Hura-Hospital (copy attached). Later we come to know their identity from local people as Usha (c) Ushavani Mandal, wife - Swapna Mandal of vill + P.O - Kalabani (the said lady), Swapna Mandal, Spouse Ganesh Mandal of vill + P.O - Kalabani (her husband) and her daughter's name is still unknown to me. It is also come to know that she is an ASHA worker under Hura block.

Therefore, I am requesting you to take this complaint as an FIR and taking necessary action as per law.
