**Sub:** Obstruction in doing Government work at 16<sup>th</sup> (15.00 km to 15.52 km) km of Jhalda-Bagmundi State Highway-4 within Jhalda Police Station in the district of Purulia- Regarding FIR for obstructing public servant in the discharge of his public functions and also forceful obstruction in doing public works.

Sir,

In connection to above this is to bring your kind notice that the PWD has taken up an improvement work at the above mentioned road stretch of Jhalda-Bagmundi State Highway-4. Some local persons are often used to create obstructions and threatened the workmen whenever any road work commences or during execution. Those persons are not even restrict themselves by using abusive language and physical assault to the public servant like Junior Engineer & Assistant Engineer in charge during their visit at site.

On 07.08.2023 at 8.30 A.M. when the entrusted agency Sudhansu Mahato, Vill+P.O-Nowdih, Jhalda, started the work, those persons suddenly came at the work site with Lathi & Other weapons and attacked the agency physically and forced him to stop the public work and the agency left the spot with fear and informed accordingly with video footage.

Sir, please note that the said road is a State Highway and in service for more than 50 years and the road is the backbone of the communication system of the district.

Considering all above facts you are hereby requested to please take appropriate measures of action against the persons obstructing public works as well as obstructing public servant or agency engaged for public works in the discharge of public functions as per Law and also provide necessary police assistance during execution of public work.
