Sir,

In continuation with the letter under ref.(i) this is to bring your kind notice that as per pre-scheduled programme repairing work at the above mentioned road stretch of Jhalda-Bagmundi State Highway-4 is started at 9.30 A.M on 22.08.2023 but immediate after commencement of work Smt. Anita Mahato W/O Nikhil Mahato (Complain already lodged against Nikhil Mahato for the obstruction on 08.08.2023 vide memo under reference) along with other 14 to 15 women came at the spot and interrupt public work, threaten the workmen with abusive language even voluntarily obstruct public servants in the discharge of their public functions.

As repeated forceful obstruction is being happened during discharging public function by the public servants, you are hereby requested to please take suitable step against the persons who are repeatedly creating hazards, in accordance with law and also afford Government Employee every assistance and protection for the discharge his official duties in the public interest.
