Respected Sir,

In producing herewith seized 02 (two) Tractors bearing Registration No (1) WB55B-5157 (Sonalika DI-734 blue colour) along with trolley (2) WB55B-5708 (Mahindra B275 DI red colour) along with trolley each Tractors loaded with sand (100 CFT approx) under proper seizure list, I beg to submit that today (09/08/2023) I, ASI Swapan Mandal along with force (1) C/-1356 Rajib Kundu (2) C/-181 Rabban Sekh all of Joypur P.S were performing Special Mobile duty vide Joypur PS CC No-1855/23 Date-09/08/2023. During my mobile duty at about 12:35 hrs received a credible source information that two Tractors loaded with sand is coming from Jahajpur Ghat, Kongashabati River towards Jahajpur village side, I along with force reached at Jahajpur village morh under Joypur PS and found that 02 (two) Tractors bearing Registration No (1) WB55B-5157 (Sonalika DI-734 B275 DI blue colour) along with trolley (2) WB55B-5708 (Mahindra B275 DI red colour) along with trolley each Tractors loaded with sand (100 CFT approx). On seeing the Police party at Jahajpur village more, the driver of the both tractors were trying to fled away. But after a hot chase, we could able to detain the both the tractors driver. On interrogation they made incoherent statement at different time. They disclosed their identity as (1) Raju Mandal (36 yrs) S/o-Late Habu Mandal of Vill-Jahajpur PS-Joypur Dist-Purulia (Driver of the tractor No-WB55B-5157) (2) Aditya Mandal (41 yrs) S/o-Nibaran Mandal of Vill-Jahajpur PS-Joypur Dist-Purulia (Driver of the tractor No-WB55B-5708). I asked both the driver to produce valid documents in respect of said sand but they failed to produce any documents regarding lifting & transportation of sand. I interrogated them thoroughly. During interrogation they admit that both the tractors driver and both the owners of the said tractors dealing with illegal sand lifting from Kangsabati riverbed and transporting the sand. Hence, I seized 02 (two) Tractors bearing Registration No (1) WB55B-5157 (Sonalika DI-734 blue colour) along with trolley (2) WB55B-5708 (Mahindra B275 DI red colour) along with trolley each Tractors loaded with sand (100 CFT approx) in between 01:05 hrs to 01:35 hrs under proper seizure list in presence of available witnesses duly signed by them and I arrested (1) Raju Mandal (36 yrs) S/o-Late Habu Mandal of Vill-Jahajpur PS-Joypur Dist-Purulia (Driver of the tractor No-WB55B-5157) (2) Aditya Mandal (41 yrs) S/o-Nibaran Mandal of Vill-Jahajpur PS-Joypur Dist-Purulia (Driver of the tractor No-WB55B-5708). After observing all formalities & disclosed them about the ground of arrest. I brought the both tractors to Joypur P.S. As such there is every reason to believe that the drivers and owners of the both tractors are dealing with sand illegally and transporting with ill motive without any valid documents and also violating the order notification vide Memo No-MDTC/SAND/02/Part-I/1602 Date-21/06/2023 regarding ban of sand lifting from riverbed.

Hence, they are liable for offence punishable U/S-188/379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver (1) Raju Mandal (36 yrs) S/o-Late Habu Mandal of Vill-Jahajpur PS-Joypur Dist-Purulia (Driver of the tractor No-WB55B-5157) (2) Aditya Mandal (41 yrs) S/o-Nibaran Mandal of Vill-Jahajpur PS-Joypur Dist-Purulia (Driver of the tractor No-WB55B-5708) and owners of the both Tractors may kindly be started and arrange for its investigation.
