In producing here with two arrested accused persons namely 1) Sumit Karmakar @ Chhatu(36 Yrs) S/o-Dhananjay Karmakar of Poddar Para, Jhalda Municipality Ward No-VIII, PS- Jhalda Dist-Purulia 2) Santosh Lahari (34 years) S/O Madhusudan Lahari of Jhalda Station Road, Ward No- XII PS - Jhalda Dist-Purulia and brought under seizure of the following articles,1) 141 (One hundred and forty one) sealed bottles of ONEREEX-TM Cough syrup(CHLORPHENIRAMINE MALEATE & CODINE PHOSPHATE SYRUP) 100 ml in each bottle, manufactured by Biogentic Drugs Pvt LTD, batch No-100523-BBH1 Mfg date-May-2023 Expiry date April-2025 in one Black Colour bag from the possession of the accused persons mentioned above and 2) one red colour TVS Appache Motor Cycle having Reg No- JH-08D/6571 Eng No-OE4GF2800022, Chassis No-MD634KE44F2664996. I do here by lodged a written complaint to the effect that on 11/08/23 at 19:35 Hrs I received a telephonic information from my source during my mobile duty that three persons were coming from Jharkhand through Jabor to Tali Centre road by a Motor Cycle with huge numbers of cough syrup for selling to others. After having received this information I informed the matter to Q/C Kotshila PS and as per direction of O/C Kotshila PS, I SI Jyotilal Mahato along with, Const-557, Ambuj Kr Mandal and Const-2242 Dinesh Ch Kar, all of Kotshila PS rushed to the said road to work out the information with Govt. Vehicle at 19:45 Hrs vide CC No-2125/2023 Dtd-11/08/2023 and Vide GDE No-436. We reached at Mantanr near Jilinglahar High School on Jabor Tali centre road at 20:05 Hrs. and after keeping our vehicle in a dark place we wait for some time and at 20:15 hrs three persons were came by a red colour Appache motor Cycle having Reg No-JH-08D/6571. We try to stop them but seeing police they started to flee away. We caught two persons red handed after hot and little chase and one person fled away with a bag. On interrogation they disclosed their name and address as mentioned above and they also disclosed that the other one was Barun Kuiry S/O Biswanath Kuiry of Vill Mohanpur PS Kotshila Dist Purulia. They also disclosed that they all are running the Cough Syrup business since long and they have been continuing this business and today they were carrying drugs for the purpose of selling to the local customers to earn money. They also stated that the person who flied away with a bag containing cough syrup was there partner Barun Kuiry. I searched them from 20:25 hrs to 20:45 hrs. On being searched one Black Colour bag containing 141(One hundred and forty one) sealed bottles of ONEREEX-TM Cough syrup(CHLORPHENIRAMINE MALEATE & CODINE PHOSPHATE SYRUP) 100 ml in each bottle, manufactured by Biogentic Drugs Pvt LTD, batch No-100523-BBH1 Mfg date-May-2023 Expiry date April-2025 (illegal drugs) found in their possession. On demand they failed to produce any valid documents/ license in respect of keeping the said drugs. So I seized the same under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there at that moment and also prepared lebel with seal of one bottle of Cough Syrup as sample taking among seized bottles I also seized one red colour TVS Appache Motor Cycle having Reg No- JH-08D/6571 Eng No- OE4GF2800022, Chassis No-MD634KE44F2664996 from 20:55 to 21:25 hrs. I arrested the said accused person for violating the Sec-27 of Drugs & Cosmetics Act-1940 at 21:30 & 21:35 hrs and informed them the ground of arrest.

I therefore pray before you to start a case against three accused persons namely 1) Sumit Karmakar @ Chhatu(36 Yrs) S/o-Dhananjay Karmakar of Poddar Para, Jahlda Municipality Ward No-VII, PS- Jhalda Dist-Purulia 2) Santosh Lahari (34 years) S/O Madhusudan Lahari of Jhalda Station Road, Ward No- XII PS - Jhalda Dist- Purulia 3) Barun Kuiry S/O Biswanath kuiry of Vill Mohanpur PS Kotshila Dist Purulia may kindly be initiated under Sec-27 of Drugs & Cosmetics Act-1940 and arrange for its investigation.
