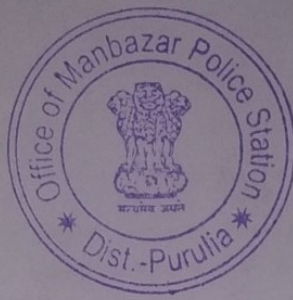

Sir,

In producing herewith the arrested accused persons namely (1) Kuldev Karmakar (30) S/O Kartick Karmakar (2) Nupur Karmakar (43) S/O Lt- Naran Karmakar & (3) Swapan Karmakar (48) S/O Lt- Naran Karmakar all are village Gopalnagar, PS- Manbazar, Dist- Purulia under arrest memo along with seized articles (1) 02 (Two) Bamboo Stick (2) Some brick Bats (3) Some broken Glasses (4) A key under proper seizure list. I would like to draw your kind attention that today at 17:45 hrs on table duty officer ASI Sambal Kr. Singh received a telephonic information from Gopalnagar village that a mob of about 100-150 assembled near the house of Partha Sarathi karmakar of that village and they were pelting stones at that house and a tension was going on there. As per direction of O/C Manbazar PS he requested ASI Pravash Bauri who was on mobile duty to look in to the matter (vide GDE no- 684 dtd- 17.08.2023).

At around 18:35 hrs ASI Pravash Bauri informed ASI Sambal Kr. Singh over mobile phone that the mob are getting violent and they were not hearing Police and he asked for reinforcement. Accordingly O/C Manbazar PS directed me to move to the spot and do the needful. Accordingly I S.I. Prabir Kr. Dey along with ASI Anirban Banerjee, C/1511 Sudarsan Bauri, C/2855 Krishna Das Karmakar, C/886 Anirudha Banerjee & LC/3044 Chandana Mandal left for village Gopalnagar, PS- Manbazar, Dist- Purulia vide C.C. No- (1354/2023 dtd- 17.08.2023).

We reached at Gopalnagar at around 19:05 hrs and found that a mob of around 100-150 (including female) assembled in front of the house of Partha Sarathi Karmakar and they were demanding before Police that Partha Sarathi Karmakar and his family members to be handed over to them and they would punish in their own hand. It was learnt that on 09.05.2023 late Riya Karmakar wife of Partha Sarathi Karmakar committed suicide due to torture of Partha Sarathi and his other family members and as per complaint of Muruli Karmakar, father of late Riya Karmakar, Manbazar PS case No- 40/23 dtd- 09.05.2023 U/S – 498A/304 B IPC was started. Chandrakola Karmakar mother of Partha Sarathi karmakar and Anita Karmakar Sister –in-law of Partha Sarathi Karmakar were arrested and Partha Sarathi also surrendered before Ld. Court and were in JC. They got bail few days ago but today they returned home. Seeing them the family members of late Riya Karmakar and some other villagers got violent and assembled to attack them. I along with other officers and force tried to pacify the mob but they paid no heed to my words and instead they started pelting stones aiming at Police and the house of Partha Sarathi Karmakar. They prevented Police to discharge their govt. duty. They also hit Police with Lathi and fists and blows and as a result ASI Anirban Banerjee C/ 2855 Krishna Das karmakar LC/3044 Chandana Mandal C/ 1511 Sudarsan Bauri and C/ 886 Anirudha Banerjee and I were injured badly. It is to be noted that before arrival of Police the mob tried to break the gate of the house of Partha Sarathi karmakar but as it was locked from inside, they locked the door from outside making them wrongfully confined. Due to their aggressive and attacking attitude some of our Police persons got injured. Finding no other alternatives we chased them and they started running away. We succeeded to apprehend the above noted three persons and on interrogation they confessed their guilt. From the possession of accused namely (1) Kuldev Karmakar S/O Kartick Karmakar of Gopalnagar a bamboo Stick was recovered and seized and another bamboo Stick was seized from the possession of (2) Nupur Karmakar S/O Late Naran Karmakar of Gopalnagar and some broken glasses, bricks bats and stones were seized from the

P.O. in their presence. On interrogation Swapn karmakar S/O Late Naran Karmakar of Gopalnagar produced a key and Stated that it was the key of the lock with which the main gate of Partha Sarathi Karmakar was locked from outside. Accordingly the lock of the main gate of the house of Partha Sarathi Karmakar was opened with the said key and the key and the lock were seized from the possession of (3) Swapn Karmakar S/o Late Naran Karmakar. After seizure they were arrested observing all the formalities regarding arrest. After that we rescued Partha Sarathi Karmakar, Chandrakola Karmakar, Anita karmakar, Aparna Mandal and Ajay Karmakar and sent them to PS for safe custody as per their demand. All injured Police personnel including me got treated at Manbazar Rural Hospital.

So I would like to request you to start a specific case under proper section of law against all the involved accused persons and arrange for its investigation.
