Sir,

In producing here with one accused person Jhantu Majhi (37) S/O Lusu Majhi of village – Jitujuri, PS- Manbazar District Purulia along with following seized articles viz-

- 1) 15 (Fifteen) Ltrs ID liquor within 02 Jarikane.
- 2) 08 pees of plastic glass

I ASI Manik Ch Mahato of Manbazar PS do here by lodged a complaint against accused namely Jhantu Majhi (37) S/O Lusu Majhi of village - Jitujuri, PS- Manbazar District Purulia to the effect that today (05.08.2023) at 19:35 hrs. in course of my evening mobile duty vide Manbazar PS G.D.E. No.183 Dtd.05.08.2023. I received a telephonic information from a reliable source that one Jhantu Majhi (37) S/O Lusu Majhi of village -Jitujuri, PS- Manbazar District Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/460 Nirmalendu Singha Mahapatra, C/794 Ajoy Kr Mahato rushed to the spot for raid by Govt. vehicle. At about 20:05 hrs. myself along with force reached at Jitujuri village and held raid in the house of Jhantu Majhi S/O Lusu Majhi of village - Jitujuri, PS- Manbazar District Purulia and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Jhantu Majhi tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly signed by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Jhantu Majhi S/O Lusu Majhi of village-Jitujuri, PS- Manbazar District Purulia as per law and arrange for its investigation.
