I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Ramchandra Tuju S/O- Debajit Tuju of Village- Kadalgora, P.O- Jitjwari, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

entered the premises of sri Ramchandra Tuju, S/O- Debajit Tuju of Village- Kadalgora, P.O- Jitjwari, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was using electricity unauthorisely from nearest- DTR LT fuse unit.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -
