To stop productions and to destabilize our factory ,few miscreants illegally and in concerted manner entered into our premises .This has been led by Sri Meghnath Maity s/o Samir Maity & others .They have done it on ill motive.At about 7 to 7.30 am on 4th Aug 2023 .Sri Maity have attacked and manhandled Sourab Chakraborty of Balitora 25 and Debidayal Banerjee of Kulsara 23 inside Packing Plant i.e inside our premises by iron rod and other sharp items , contractor of concerned workers have given complain in writing .Attack took place to kill the guards on duty also of Gorkha Securitas on duty.

In view of above circumstances we fervently request your kindness to nab the culprits so that they will desist from such activities .Otherwise it will be too difficult to run a Factory wherein we had created more than 400 direct employments.



