Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith arrested accused person namely Papun Keora (48 years) S/O-Lt. Madhu Keora of Vill-Parbelia 8 No., PS-Neturia, Dist-Purulia with seizure of 17 pcs sealed bottles of Bumper Country spirit containing 300 ml each which were seized under proper seizure list.

I beg to submit that today (08.08.2023) while I, ASI Sitaram Mandi, along with force were performing special mobile duty vide Neturia PS GDE No-411 Dt. 08.08.2023 and acting on source information after consulting you at about 19:25 hrs reached at Parbelia 8 No. More and held raid in the hotel styled as Piku Hotel of Papun Keora (48 years) S/O- Lt. Madhu Keora of Vill-Parbelia 8 No., PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his hotel, on demand he failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 17 pcs sealed bottles of Bumper Country spirit containing 300 ml each which were seized under proper seizure list duly signed by witnesses and out of it labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s-50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accused namely Papun Keora (48 years) S/O- Lt. Madhu Keora of Vill-Parbelia 8 No., PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1228 Babulal Hansda (2) NVF/176 Phakir Ch. Paul and (3) NVF/487 Kirtan Singh Sardar all are of Neturia PS accompanied me.

Under the above facts and circumstances, I therefore pray that a specific case may kindly be started against Papun Keora (48 years) S/O- Lt. Madhu Keora of Vill-Parbelia 8 No., PS-Neturia, Dist-Purulia under proper section of law.
