Sub: Complain to start a specific case.

Sir,

In producing herewith one arrested accused person namely Dilu Shekh (63 yrs) S/O- Lt. Jabhed Shekh of Vill-Murulia, PS-Santuri, Dist-Purulia along with one old bicycle loaded with 300 kg (approx) raw coal and approx 05 MT raw coal seized at Santalmoutha area, PS-Neturia, Dist-Purulia in hidden condition in bushy area, I do hereby lodge a complaint to the effect that on 11.08.23 I, SI Biswajit Banerjee, along with C/1319 Soumen Koley, C/174 Tapan Das Bauri and C/753 Shyam Sundar Mahato all are of Neturia PS were engaged in PS area day mobile duty vide Neturia PS GDE No- 529 Dt. 11.08.2023 & CC No- 2514/23 Dt. 11.08.23. In course of PS area day mobile duty at about 11:05 hrs received secret source information of stocking of huge quantity of raw coal at Santalmoutha area PS-Neturia, Dist-Purulia. Accordingly I shared the information with you and after receiving your kind order myself along with force left for Santalmoutha area to work out the information. Being reached there at 11:35 hrs and after search at the bushy area at Santalmoutha side (Lat-23.622994 & Long-86.835321) and found huge quantity of raw coal was stocked there in hidden condition and found accused Dilu Shekh (63 yrs) S/O- Lt. Jabhed Shekh of Vill-Murulia, PS-Santuri, Dist-Purulia was riding one old bicycle loaded with raw coal at Santalmoutha. He has been asked to produce any valid document in support of loaded coal on bicycle and stock raw coal but he failed to produce any valid documents. Accordingly, I seized one old bicycle loaded with 300 kg (approx) raw coal out of it 05 Kg as sample and another raw coal weighing about approx 05 MT found at Santalmoutha out of it 05 kg as sample under proper seizure list duly signed by available witnesses.

Accordingly, I arrested him after maintaining all arrest rule and on interrogation he disclosed the name of his accomplices as (1) Raja Bouri S/O- Lt. Bamapada Bauri (2) Sk. Hamij S/O- Lt. Ibrahim (3) Bhokta Bouri S/O- Lt. Laxman Bouri (4) Majibul Khan S/O- Lt. Alid Khan (5) Somim Akhtar S/O- Lt. Sk. Saforid and (6) Sk. Salamot S/O-Lt. Sk. Mokbul all are of Vill-Murulia, PS-Santuri, Dist-Purulia & others who were engaged in procuring illegal coal from illegal coal pit and transporting the same in a clandestine manner to another district/state. Necessary arrangement has been made for shifting approx 05 MT seized raw coal and seized bicycle with loaded coal at Neturia PS.

So, it is reasonable to believe that the arrested accused Dilu Shekh (63 yrs) S/O- Lt. Jabhed Shekh of Vill-Murulia, PS-Santuri, Dist-Purulia and above noted his accomplices & others had obtained the said coal either by theft or by any fraudulent means from the illegal coal pits and trying to dispose the same coal in a clandestine manner to another district/state knowing it to be stolen.

Therefore, I pray that a specific case may kindly be registered against accused (1) Dilu Shekh (63 yrs) S/O- Lt. Jabhed Shekh (2) Raja Bouri S/O- Lt. Bamapada Bauri (3) Sk. Hamij S/O- Lt. Ibrahim (4) Bhokta Bouri S/O- Lt. Laxman Bouri (5) Majibul Khan S/O- Lt. Alid Khan (6) Somim Akhtar S/O- Lt. Sk. Saforid and (7) Sk. Salamot S/O-Lt. Sk. Mokbul all are of Vill-Murulia, PS-Santuri, Dist-Purulia & others under proper section of law.
