Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith arrested accused person namely Tapan Mudi (32 yrs) S/O- Lt. Gurupada @ Gorak Mudi of Vill-Pochhara, PS-Neturia, Dist-Purulia with seizure of 19 pcs sealed bottles of Bumper Country spirit containing 300 ml each which were seized under proper seizure list.

I beg to submit that today (13.08.2023) while I, SI Sk. Rahaman, along with force were performing special mobile duty vide Neturia PS GDE No-648 Dt. 13.08.2023 and acting on source information after consulting you at about 18:05 hrs reached at village Pochhara and held raid in the house of Tapan Mudi (32 yrs) S/O- Lt. Gurupada @ Gorak Mudi of Vill-Pochhara, PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his house, on demand he failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 19 pcs sealed bottles of Bumper Country spirit containing 300 ml each which were seized under proper seizure list duly signed by witnesses and out of it labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s-50 Cr. P.C. and handed over a copy of the same to arrestee.

The arrested accused namely Tapan Mudi (32 yrs) S/O- Lt. Gurupada @ Gorak Mudi of Vill-Pochhara, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1550 Bharat Ghosh (2) C/159 Dinesh Sardar and (3) NVF/487 Kirtan Singh Sardar all are of Neturia PS accompanied me.

Under the above facts and circumstances, I therefore pray that a specific case may kindly be started against Tapan Mudi (32 yrs) S/O- Lt. Gurupada @ Gorak Mudi of Vill-Pochhara, PS-Neturia, Dist-Purulia under proper section of law.
