





The above named complainant begs to state as follows:

 That the complainant is the legally married wife of the accused person No. 1 and their marriage took place and was solemnized on 14<sup>th</sup> Ashar 1426 B.S. corresponding to 30/06/2019 according to Hindu rites and customs prevailing in their community at Village- Shibdih, within P.S. Purulia(M) and within the jurisdiction of this Ld. Court. The marriage was consummated and the marriage tie between the complainant and the accused person No. 1 still subsists.



That at the time of marriage the father of the complainant was compelled to give Rs. 30,000/- (Rupees thirty thousand) only in cash, golden ear rings and nose rings, one golden chain and silver neckless to the accused person No. 1, furnitures and utensils valued at Rs. 50,000/- (Rupees fifty thousand) only to the accused persons as per their demands.

- 3. That after marriage the complainant had been to the house of the accused persons.
- 4. That after some days from the date of marriage the complainant lived with the accused person No. 1 as husband and wife peacefully but thereafter the accused person No. 1 at the active aid and abatement of accused persons No. 2 to 5 who are in joint mess pressurized to the complainant to bring Rs. 50,000/- (Rupees fifty thousand) only from her father's house. The complainant narrated the illegal demand of dowry of the accused persons. The father of the complainant confessed his inability to pay the same as he is very poor person, then all the accused person started torture upon the complainant both physically and mentally in various ways. She was not provided sufficient foods and clothes. The accused person No. 1 assaulted to the complainant off and on without any reason, but the complainant accepted such type of torture and ill-treatment with a hope that the accused persons would change their conduct upon the complainant, but it was on vain.
- 5. That then due to wed lock in between the complainant and the accused person No. 1 became pregnant, yet the accused persons were continuing torture upon the complainant, both physically and mentally. Then the complainant reported the matter to her father and on hearing the news of torture upon the complainant, the parents of

the complainant in the month of Agrahayan 1426 B.S. brought back complainant to his house. During stay the father's house of the complainant the accused persons did not provide any sort of maintenance, fooding, clothings and treatment cost to the complainant and on 14/07/2020 the complainant gave birth to a female child whose name is Mousumi Tewari and now she is aged about 3 years and under the care and custody of the complainant.

- 6. That after giving birth of female child the accused persons neglected to the complainant, however the accused person No. 1 brought back the complainant and her new born baby to his house in the month of Shraban on that year with an assurance to keep and maintain the complainant and her baby properly.
- 7. That thereafter after some days latter the act of cruelty by the accused persons upon the complainant was increasing day by day and that she was denjed of all the necessities and that the accused person No. 1 assault, the complainant off and on with the intention that the complainant will either have to commit suicide or leave her matrimonial home voluntarily and such act of cruelty was continuing upto 14th June 2023. The accused person No. 1 threatened to the complainant with dire consequences saying that he is Civic Volunteer of Jhalda P.S., so Police could not any harm or lodge any case against them.
- 8. That since 15/06/2023 all the accused persons stopped providing foods to the complainant and increased torture upon her, as a result of which the complainant fell ill and then on that date accused Debnarayan Tewari by showing a sword threatened her saying that to kill her by two pieces and the accused person No. 1 threatened her that he is a Civic Volunteer so the complainant could not any harm or loss to him.

Then the complainant informed the matter to her father and one Dipak Kumar Dubey, the then Gram Panchayet member, then on 19/06/2023 the father of the complainant, Dipak Kumar Dubey, Mahadeb Dubey and some other rescued the complainant and her daughter from her measurable condition from her matrimonial home and they brought back them to the father's house of the complainant

and at that time the accused person No. 1 snatched away her Mobile Phone from her possession and since then the complainant and her daughter have been residing at her father's house at Village- Shibdih.

- 9. That the complainant reported matter to the I.C. Purulia(M) P.S. on 22/06/2023 but the Police of Purulia(M) P.S. refused to accept the F.I.R. and then the complainant send the said F.I.R. through registered post with A.D. to the I.C. Purulia(M) P.S. on 22/06/2023 but the Police did not take any action against the accused persons till 30/06/2023. Then on 30/06/2023 the complainant reported the matter to the S.P., Purulia, but of no good till today and as such the complainant has been compelled to file this Misc. Petition today.
- 10. That thus from the very inception of the marriage the complainant was subjected to cruelty and torture both physically and mentally and the accused persons. So, all the accused persons have committed offence under the Law.
- 11. That for proper investigation of matter and for search and seizure a a Police case is solicited.

It is, therefore, prayed that your Honour will be graciously pleased to send this petition of complaint to the Inspector-in-Charge Purulia(M) P.S. for investigation treating the same as an F.I.R. U/S- 156(3) Cr. P. Code for the ends of Justice.
