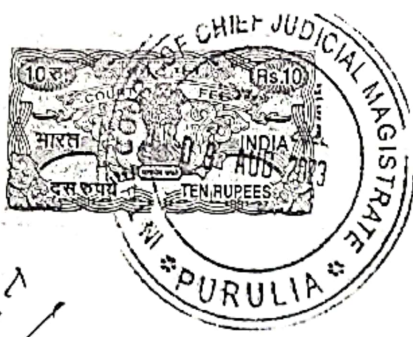

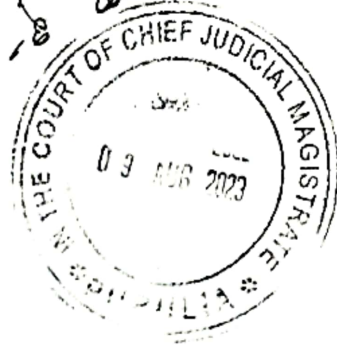

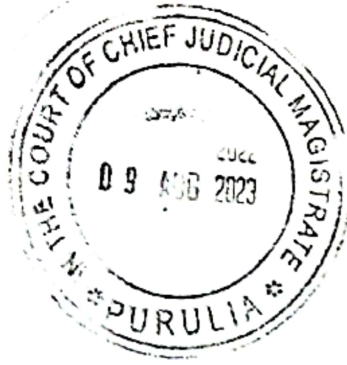

The above name complainant begs to state as follows:-

1) That your complainant is a permanent resident of Village + P.O. - Chakra, P.S.- Purulia (M), Dist.- Purulia and his marriage was solemnized on 25/04/2006 corresponding to 11<sup>th</sup> Baisakh 1413 and the marriage was solemnized at Village + P.O. - Chakra, P.S.- Purulia (M), Dist.- Purulia and within the jurisdiction of this Ld. Court.

2) That your complainant married with acd No 1 on dated 25/04/2006 corresponding to 11<sup>th</sup> Baisakh 1413 and their marriage was solemnized as per Hindu rights and rituals of their society at Village + P.O. - Chakra, P.S.- Purulia (M), Dist.- Purulia.

3) That at the time of marriage as per demand of the Opp. parties a cash of Rs. 80,000/- by cycle, silver ornaments, utensils were given which approximately cost Rs. 1,70,000/- was given to the Opp. parties.

4) That after marriage accused no. 1 took your petitioner at Village-Kailashnagar Ispat Colony, P.O. & P.S.- Chas, Dist.- Bokaro (Jharkhand) and started to live there as husband and wife by sharing bed and board.



5) That Approximately after a peaceful matrimonial journey of six months by accused persons started torture upon your petitioner physically and mental. The accused persons started to demand Rs. 1,00,000/- as additional dowry from your complainant.

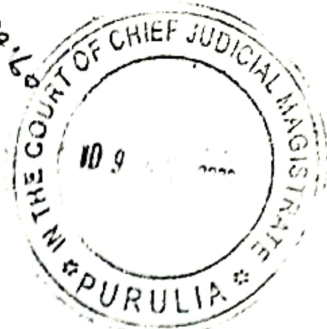
6) That as the complainant revealed the financial incapability of her father's house to meet up their additional demand the accused persons intensified the quantum of torture upon your complainant day after day yet your complainant tolerated everything keeping a false hope in the mind that sooner or later good sense will prevail and her matrimonial journey will again smooth.

7) That suddenly on dated 06.11.2022 at about 10.00 to 11.00 a.m. all the accused persons assaulted your petitioner with fist and blows and as the minor children of your petitioner approached to save their mother the minor children were also assaulted and drove your petitioner out of the house along with her minor children. Since then your petitioner leaving at her father house at Village + P.O. - Chakra, P.S.- Purulia (M), Dist.- Purulia.

8) That but the ill fate of your complainant continues and during her stay at village & P.O. - Chakra, P.S.- Purulia (M), Dist.- Purulia, at her father's house all of a sudden on dated 05.07.2023 at about 11 - 12 p.m. the accused persons came to the father's house of your complainant and accused no. 1, felled your petitioner down to the earth by way of holding the locks of hair of your petitioner and putting jerk and the other accused persons assaulted

your petitioner with fist and blows and also assaulted the three minor children of your petitioner uttering filthy language.



10) That hearing the hue and cry the witnesses and the villagers approached the police and the accused persons fled away.

11) That your complainant reported the incident to the Inspector-in-charge Purulia (M) P.S. and Superintendent of Police of Purulia but till today not any action has been taken by the police against the accd. persons so your complaint come up before this Ld. Court.

11) That your petitioner is a poor woman and is not in position to pull the burden of complain case so, a police case is desirable.

12) That the accd. persons have committed the offence U/s 498A/323/34 IPC & 3/4 D.P. Act. and they are liable to be punished accordingly.

It is therefore prayed that your Honour may graciously be pleased to accept the petition and further be pleased to direct the I.C. of Purulia (M) P.S. treating the same as F.I.R. U / S - 156(3) Cr.P.C. and to investigate the matter and started a specific case against the accused persons.
