

Sub: Prayer for lodging FIR.

Sir,

In producing herewith one arrested accused person namely Yudhisthir Mahato (35 Yrs) S/o- Lt. Kariram Mahato of Vill- Simulia, PO- Olgara, PS- Pindrajora, Dist- Bokaro, Jharkhand A/P Vill- Rudra, PS- Purulia (M), Dist- Purulia along with seizure list and seized articles.

I beg to state that today (19.08.2023) evening while I along with force (i) C/699 Biswajit Banerjee (ii) C/768 Ajit Kr. Murmu & (iii) HG- 1576 Shaktipada Mahato all of Purulia (M) PS vide GDE No- 897 & C.C No- 3346/2023 Dtd. 19.08.2023. During my anti crime night mobile duty, at about 20.35 hrs I received a secret tip off that an illegal possession of a huge quantity of liquors. Subsequently, I informed you and as per your direction, I rushed to the spot at Rudra village morh at SHIB SHAKTI DHABA and after arriving at the spot and as per your instruction conducted raid in the said DHABA of Yudhisthir Mahato under this PS at about 20.55 hrs. During the raid some people fled away and detained one person. On being asked he disclosed his identity as Yudhisthir Mahato (35 Yrs) S/o- Lt. Kariram Mahato of Vill- Simulia, PO- Olgara, PS- Pindrajora, Dist- Bokaro, Jharkhand A/P Vill- Rudra, PS- Purulia (M), Dist- Purulia. On interrogation he confessed that he procured and stocks the liquors for selling illegally from his DHABA. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors from his DHABA. Subsequently, I seized (i) 20 (Twenty) sealed bottles country spirit (CAPTAIN) each containing 600 ml (ii) 08 (Eight) sealed bottles foreign liquors, containing each 375 ml (iii) 06 (Six) sealed bottles foreign liquors (IMPERIAL BLUE), containing each 750 ml (iv) 12 (Twelve) bottles sealed foreign liquors (McDowell's), containing each 180 ml (v) Kingfisher Strong (BEER) 15 (Fifteen) sealed Bottles, containing each 650 ml. In which 01 sealed bottles were taken as samples from each item. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 21.05 & 21.35 hrs.

Accordingly, I arrested the above noted accused person at 21.45 hrs after maintaining all formalities regarding arrest. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray you kindly take lawful action against the arrested accused person namely Yudhisthir Mahato (35 Yrs) S/o- Lt. Kariram Mahato of Vill- Simulia, PO- Olgara, PS- Pindrajora, Dist- Bokaro, Jharkhand A/P Vill- Rudra, PS- Purulia (M), Dist- Purulia under proper section of Law.
