Sub: Prayer for lodging FIR.

Sir,

In producing herewith one arrested accused person namely Sachitananda Gope @ Sachida @ Laltu (52 Yrs) S/o- Lt. Budhu Gope of Vill- Mamurjore, PS- Purulia (M), Dist-Purulia along with seizure list and seized articles.

I beg to state that today (20.08.2023) evening while I along with force namely (i) C/955 Arabinda Roy (ii) C/966 Amrit Banerjee all of Purulia (M) PS vide GDE No- 955 & C.C No- 3357/2023 Dtd. 20.08.2023 were performing anti crime night mobile duty, then at about 18.55 hrs, I received a secret tip off an illegal possession of a huge quantity of liquors at a temporary shed beside Biltora High School. Subsequently, I informed you and as per your direction, I rushed to the spot at a temporary shed beside Biltora High School and after arriving at the spot and as per your instruction conducted raid at a temporary shed beside Biltora High School under this PS at about 19.15 hrs. During the raid some people managed to escape and detained one person. On being asked he disclosed his identity as Sachitananda Gope @ Sachida @ Laltu (52 Yrs) S/o- Lt.
