Sub: Prayer for lodging FIR.

Sir,

In producing herewith one arrested accused person namely Sachitananda Gope @ Sachida @ Laltu (52 Yrs) S/o- Lt. Budhu Gope of Vill- Mamurjore, PS- Purulia (M), Dist- Purulia along with seizure list and seized articles.

I beg to state that today (20.08.2023) evening while I along with force namely (i) C/955 Arabinda Roy (ii) C/966 Amrit Banerjee all of Purulia (M) PS vide GDE No- 955 & C.C No- 3357/2023 Dtd. 20.08.2023 were performing anti crime night mobile duty, then at about 18.55 hrs, I received a secret tip off an illegal possession of a huge quantity of liquors at a temporary shed beside Biltora High School. Subsequently, I informed you and as per your direction, I rushed to the spot at a temporary shed beside Biltora High School and after arriving at the spot and as per your instruction conducted raid at a temporary shed beside Biltora High School under this PS at about 19.15 hrs. During the raid some people managed to escape and detained one person. On being asked he disclosed his identity as Sachitananda Gope @ Sachida @ Laltu (52 Yrs) S/o- Lt. Budhu Gope. of Vill- Mamurjore, PS- Purulia (M), Dist- Purulia. On interrogation he confessed that he procured and stocks the liquors for selling illegally at the temporary shed beside Biltora High School. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors. Subsequently, I seized 20 (Twenty) sealed bottles country spirit (DIL Khush) each containing 600 ml. In which 01 sealed bottles was taken as samples. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 19.20 & 19.30 hrs.

Accordingly, I arrested the above noted accused person at 19.32 hrs after maintaining all formalities regarding arrest. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray you kindly take lawful action against the arrested accused person namely Sachitananda Gope @ Sachida @ Laltu (52 Yrs) S/o- Lt. Budhu Gope of Vill- Mamurjore, PS- Purulia (M), Dist- Purulia under proper section of law.
