In producing herewith 03 (three) arrested accused persons namely (1) Prasenjit Bauri(26 Yrs.) S/O Ramdhanu Bauri of Bhadudanga, Puapur, P.S- Neturia, Dist. Purulia, (2) Bidyut Bauri(22 yrs.) S/O Padmalochan Bauri of Durmut, P.S- Raghunathpur, Dist. Purulia, (3) Md. Nasim Ansari(22 yrs.) S/O Md. Kasim Ansari of Dahibari, P.O- Benagoria, P.S- Panchet, Dist.- Dhanbad, Jharkhand along with following seized articles- (1) 02 (two) motor cycles bearing (i) Bajaj Pulsar125 without registration number having Engine No. JEXCPB67766, Chassis No. MD2B72BX8BCB56058, (ii) Hero Glamour Red coloured bearing Registration No. WB82D7816, having Engine No. JA07ACLGH09468, Chassis No. MBLJAW-55LGH10069; (2) 04(four) numbers of mobile set bearing (i) Oppo A76, Model No. CPH2375, Colour OCEAN Blue, IMEI No. 865763057139559, 865763057139542 fitted with SIM No. 7541853336(JIO) and 9641495822(Jio), (ii) 1+ Model- No. CPH2381, Colour- OCEAN Blue having IMEI No. 866861062162399 and 866861062162381 fitted with SIM No. 9064686806(Jio), (iii) Realme 5i, Model No. RMX2030, Colour- Sea Green, IMEI No. 867516043193157 & 867516043193140 fitted with SIM No. 8918235742 (Jio), (iv) itel A48 Model- itel L6006, Colour- Sea Green, having IMEI No. 353972542440501 & 353972542440519 fitted with SIM No. 7319418461(Airtel); (3) 01(one) Black coloured school bag(back carrying) from the possession of Md. Nasim Ansari in which contains (4) 01 (one) small torch, (5) 02(two) Screw Driver, (6) 01 (one) big size knife, (7) 01(one) wire cutting Plus, (8) Nylon rope green coloured length 10 feet.

That today (01.08.23) at 20:25 hrs I received secret information from a source that a gang of criminals comprising of 05(five) heads under the leadership of Md. Nasim Ansari (22 yrs.) S/O Md. Kasim Ansari of Dahibari, P.O Benagoria, P.S Panchet, Dist.- Dhanbad, Jharkhand with 03(three) motor cycles were roaming in front of ICICI Bank, Ranchi Road, Purulia with a view to commit dacoity at the above noted place.

Accordingly, I informed the matter to I/C Purulia (T) PS over mobile phone and as per his kind instruction I along with C/1042 Prakash Mondal, C/950 Mathur Mondal, HG/222 Alope Bauri & HG/1454 Prakash Char vide Purulia (T) PS C.C. No. 2332/23 dated- 01.08.2023 and GDE No- 33 left to work out the information by a Govt. vehicle. At 20.45 hrs we reached at above noted place keeping the vehicle from a distance of about 50 yards & we cordoned them. But when we reached nearer then they all started to flee away from that place by their Motor cycle. After a hot chase we could able to apprehend above noted 03 persons & after disclosing our identity we detained them. On a thorough interrogation they disclosed their identity as noted above and they gave incoherent statement in different times which is very suspicious. They also stated that one Nasiruddin Ansary S/O Not known of Idgamore, P.S- Narayanpur, Dist. Jamtara, Jharkhand Mob. No. 9609827211/ 9113792038 & (5) Sahil- details not known, Mob. No. 8240394560/9749705769/8240209513/9123050038 were with them but they fled away by another motorcycle. On being searched I seized (1) 02 (two) motor cycles bearing (i) Bajaj Pulsar125 without registration number having Engine No. JEXCPB67766, Chassis No. MD2B72BX8BCB56058, (ii) Hero Glamour red colour bearing Registration No. WB82D7816,

having Engine No. JA07ACLGH09468, Chassis No. MBLJAW-55LGH10069; (2) 04(four) numbers of mobile set bearing (i)Oppo A76, Model No. CPH2375, Colour- OCEAN Blue, IMEI No. 865763057139559, 865763057139542 fitted with SIM No. 7541853336(Jio) and 9641495822(Jio), (ii)1+ model No. CPH2381, Colour OCEAN Blue having IMEI No. 866861062162399 and 866861062162381 fitted with SIM No. 9064686806(Jio), (iii) Realme 5i, model No. RMX2030, Colour- Sea Green, IMEI No. 867516043193157 & 867516043193140 fitted with SIM No. 8918235742 (Jio), (iv)itel A48 Model- itel L6006, Colour- Sea Green, having IMEI No. 353972542440501 & 353972542440519 fitted with SIM No. 7319418461(Airtel); (3) one black coloured school bag(back carrying) from the possession of Md. Nasim Ansari in which contains (4) 01 (one) small torch, (5) 02(two) Screw Driver, (6) 01 (one) big size knife, (7) 01(one) wire cutting Plus, (8) Nylon rope green coloured length 10 feet. Thereafter, in presence of them as well as witnesses, seized the above noted articles under proper seizure list & labelled. So it is crystal clear that they were assembled in that area to commit dacoity in bank and thus liable for punishment U/S 399/402 IPC. The above noted accused persons were arrested maintaining all guidelines of Hon'ble Supreme Court of India and seized the above articles preparing seizure list duly signed by accused persons and available witnesses. The entire process of seizure & arrest has been completed from 21:05 hrs. to 21:45 hrs. It is crystal clear that they were assembled at that place to commit dacoity in Bank and after committing the crime they would flee away by their motor cycle.

On return to PS, I lodge complainant against (1) Prasenjit Bauri(26 Yrs.) S/O Ramdhanu Bauri of Bhadudanga, Puapur, P.S- Neturia, Dist.- Purulia, (2) Bidyut Bauri(22 yrs.) S/O Padmalochan Bauri of Durmut, P.S- Raghunathpur, Dist. Purulia, (3) Md. Nasim Ansari (22 yrs.) S/O Md. Kasim Ansari of Dahibari, P.O Benagoria, P.S Panchet, Dist.- Dhanbad, Jharkhand Nasiruddin Ansary S/O Not known of Idgamore, P.S- Narayanpur, Dist. Jamtara, Jharkhand Mob. No. 9609827211/ 9113792038 & (5) Sahil- details not known, Mob. No. 8240394560/9749705769/8240209513/9123050038 for starting a case U/S 399/402 IPC and also for arranging its investigation.
