Sub: Physical assault on my Husband namely Manish Kumar Singhania

Respected Sir,

My name is Rinku Singhania, wife of Manish Kumar Singhania son of Banwari lal Singhania, resident of Nathu babu lane , Chowk Bazar, Ward no. 13, Purulia, P.O. + P.S. + Dist. Purulia. I am writing to bring a serious matter to your attention that occurred on 14th august, 2023 at around 3 PM when my husband was in office and Mr. Binod Kumar Singhania son of late Govind Prasad singhania, resident of Nathu babu lane, Chowk Bazar, Ward no. 13, Purulia, P.O. + P.S. + Dist. Purulia Came to our office to start a dispute regarding a common passage between both our properties.

After a verbal argument, and also using slang language Binod Kumar Singhania called via mobile phone two local goons namely Hemanth Mahato and Basant Mahato both of village Gunja ,Bartard P.S. Joypur to use physical force and physically assault my husband. They also tried to hit him with a iron chair but luckily he was saved by the local public. During the physical assault they used force to hit my husband on the chest, scratching him on both arms and also trying the press his neck using both hands and a cloth in an attempt to kill him on the orders of Binod Kumar Singhania son of late Govind Prasad singhania, whose exact words were in Hindi "Maar do Sala ko".

My husband has incurred serious injuries and was admitted to Deben Mahata Government Medical college and hospital Purulia, where a hand X-ray was performed, a chest x ray was performed and two injections were given to relive him from internal injuries that were occurred as a result of the physical assault. The hospital has advised my husband complete bed rest.

This incident has caused us a great deal of distress and anxiety, and I firmly believe it is in the public interest that this issue is dealt with appropriately to ensure such an event doesn't recur. Therefore, I kindly request you to take immediate action against those involved. XCTOX COPY of Rinku linghania

Attached to this letter are medicine slip and discharge ticket of Manish kumar Singhania left against medical advice. Due to the medical treatment of Manish Kumar Singhania, we have incurred a delay of two days in submitting this complaint.

I am willing to cooperate fully in any investigation that follows and provide any further information as required. Please let me know the next steps in this process. I would greatly appreciate your immediate action on this matter. Thank you for your service and your dedication in maintaining peace and order in our community.
