Sub: Prayer for start a specific case.

Sir,

In producing herewith accused Matru Gupta (40 yrs) S/O- Sriram Gupta of Karpurbagan, Ward No-21, P.S- Purulia (T), Dist- Purulia and (2) Sk Mohammad Ali (29 yrs) S/O- Sk Barkat of Sindarpatti, Ward no-10, P.S- Purulia (T), Dist- Purulia alongwith one seized article- (1) one cut piece of iron made pipe length 2ft. 1 inch and diameter 32 cm, (2) One aluminum cable in which some portion covered by rubber, total length 11 ft. and diameter 6 cm, (3) one aluminum cable length 19 ft. 6 mm, (4) one aluminum cable length 64 ft. diameter 6 mm, (5) one aluminum cable length 72 ft. 3 cm, (6) 07 (seven) cut pieces of iron made pipe length 02 ft. approx and diameter 32 cm.

I, SI Ashoke Kumar Mahata received a secret source information vide Purulia (T) PS GDE No. 1563 Dated 23.08.23 that Some stolen articles are kept in the Go down of **Vijoya Steel Enterprise,(Matru Kabadi)** situated at Karpurbagan, Ward No-21, P.S- Purulia (T), Dist- Purulia . I inform the matter to I.C Purulia (T) P.S and as per his kind order myself alongwith HG/1454 Prakash Char, HG-222 Alok Bauri, Vide CC No-2590/23, Dated-23.08.23 and GDE No-1564 Dated-23.08.23 left the PS with a view to work out the information. Myself along with force reached at **Vijoya Steel Enterprise,(Matru Kabadi)** situated at Karpurbagan, Ward No-21, P.S- Purulia (T), Dist- Purulia and found that (1) Matru Gupta (40 yrs) S/O- Sriram Gupta of Karpurbagan, Ward No-21, P.S- Purulia (T), Dist- Purulia and (2) Sk Mohammad Ali (29 yrs) , S/O- Sk Barkat of Sindarpatti, Ward no-10, P.S- Purulia (T), Dist- Purulia present there on being asked both of them stated different statements in different times about the owner of the **Vijoya Steel Enterprise,(Matru Kabadi)**. Hence I searched the Go dawn and premises area and found that (1) one cut piece of iron made pipe length 2ft. 1 inch and diameter 32 cm, (2) One aluminum cable in which some portion covered by rubber, total length 11 ft. and diameter 6 cm, (3) one aluminum cable length 19 ft. 6 mm, (4) one aluminum cable length 64 ft. diameter 6 mm, (5) one aluminum cable length 72 ft. 3 cm, (6) 07 (seven) cut pieces of iron made pipe length 02 ft. approx and diameter 32 cm is kept there. Both of them failed to produce any satisfactory account for possessing of above noted articles. Hence I seized the above articles in between 19:25 hrs to 20:15 hrs. from the possession of (1) Matru Gupta (40 yrs) S/O- Sriram Gupta of Karpurbagan, Ward No-21, P.S- Purulia (T), Dist- Purulia and (2) Sk Mohammad Ali (29 yrs) , S/O- Sk Barkat of Sindarpatti, Ward no-10, P.S- Purulia (T), Dist- Purulia.

On demanding they failed to produce any kinds of valid papers in respect of seized article. As they failed to produce any kind of papers/documents in respect of seized articles , so they are arrested, maintaining all formalities.

In course of time, myself prepared seizure list which is duly signed by the accused persons namely- Matru Gupta S/O- Sriram Gupta and (2) Sk Mohammad Ali (29 yrs), S/O- Sk Barkat as well as other witnesses. Myself also prepare their Memo of Arrest and give them a copy of the same. Myself and force thereafter return to PS from Karpur Bagan.

Under the circumstance, I pray a specific case may kindly be started under proper section of law against the above noted arrested persons namely (1) Matru Gupta and (2) Sk. Mohammad Ali and others.
