To, The Inspector in Charge Purulia (T) Police Station Purulia.

Sir

In producing herewith the accused person namely Biswajit Mahata, (30 years) S/O- Ajit Mahata of Village- Barasini, PO- Belma, P.S- Purulia (M) Dist- Purulia along with seized articles i.e. 20 piece of five hundred Rupee (500/-) currency note and (12 no's of notes seems to be fake) under proper seizure list.

Today (13.08.23) at 15:15 hrs duty officer ASI Raju Mukherjee received telephonic information from Shibu Gorai, S/O- Late Manmatha Gorai of Nimtarn, P.S- Purulia (T), Dist- Purulia garment shop owner that today at 15:05 hrs one person came to his garment shop and after purchasing the Garments from his shop pay rupees 7000/- cash containing 14 no's of 500 five hundred rupee notes, but he doubt that 06(Six)500 hundred rupees notes are assumed to be fake. ASI Raju Mukherjee diarized the matter vide Purulia (T) P.S GDE No-918 Dated-13.08.23 and inform the matter to I.C Purulia (T) P.S and directed me to work out the information. Accordingly I ASI Sk Abdul Jamshed along with (1) C/2366 Anupam Das, (2) C/ 3192 Tarun Sahu, (3) C/2041 Uttam Man, (4) C/2345 Deb Shankar Barik, (5) C/2394 Kushal Mandal all are of Purulia Town P.S reached at Purulia Chowk Bazar Main road at the garment shop of Shibu Gorai and found one person who give the 500 rupee currency notes to the shop owner. On being asked he state different statements in different times which was suspicious to me. After a long interrogation he disclosed his identity as Biswajit Mahata, (30 years) S/O- Ajit Mahata of Village-Barasini, PO- Belma, P.S- Purulia (M) Dist- Purulia During search on his person in presence of local witnesses 06 pieces of five hundred (500) currency notes (assumed to be faked) were found in his possession which kept in his left side pant pocket. On being asked about 20 pieces of five hundred rupee currency notes (12 no's of notes seems to be fake) he could not give any satisfactory answer in respect of possession of such notes. At last he confessed that he collected those notes from Raghunathpur side where some persons are involve trafficking of forged currency notes in Purulia District to dispose the same to another who will transform the fake currency as genuine. He confessed that he has been involved in the racket. Hence I seized 20 pieces of 500 hundred (Rs-500/-) rupees currency note (assumed to be fake) under proper seizure list. Copy of the seizure list was given to the accused person acknowledge in the seizure list. After seizure all the seized article properly sealed and level in presence of the witnesses and persons seized level were made in between 16:25 hrs to 17:15 Hrs. Hence, I arrested him at 17:45 hours after conveying him the ground of arrest after proper memo of arrest and follow all the guidelines of Apex Court.

Under this circumstance, I request you to initiate a case against Biswajit Mahata, (30 years) S/O-Ajit Mahata of Village- Barasini, PO- Belma, P.S- Purulia (M) Dist- Purulia and others U/S 489A/489B/489C/120B IPC who are damaging the economical balance of the market and destroying our society by using this fake currency. The racket should detect and arrest the rest accused persons immediately.
