**Subject: - FIR against Sk Julfikar (alias Julfakar), Son of Late Rafique, resident of Saudagar Bandh Para, Purulia (T) thana, Dist Purulia.**

Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1/b of the electricity Act 2003, Amendment of 2007 as stated here under.

On 09/08/2023 at 15.10 Hrs. I, Sri Subhajit Pratihar AE & SM Purulia CCC along with Biswanath Barui (AE S&LP attached to Purulia Regional Office WBSEDCL), Fiya Pathak (JE Purulia CCC), Anurag Pandey (OE Purulia CCC), Sankar Ch Mahato (ACM Purulia Regional Office WBSEDCL), Dayamay Mahato (Sr TSH Purulia Region Office WBSEDCL) went to make an inspection to workout upon a source information regarding theft of electricity for at the domestic premises of Sk. Julfikar, Son of Late Rafique, resident of Saudagar Bandh Para, Purulia (T) thana, Dist Purulia.

During the time of inspection at the premises 1 no of electricity meter were found having serial no L05571611 (Consumer id 202601267, Consumer Name - Sk. Julfikar).

It was observed that accused Sk Julfikar (alias Julfakar) has made unauthorized use of electricity under section 135 1/b, i.e. bypassing the energy meter by way of inserting bypass arrangement in incoming of meter serial no L05571611 thus bypassing the electricity consumption registration in meter and hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using Fan 2 nos (80 watt each), Light 3 nos (12 watt each), Fridge 1 nos 170 watt.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected the service lines in the same premises from pole with the help of LT Mobile Van Team and removed & seized 2 core pvc cable of yellow colour with bypass arrangement. Prepared seizure list duly signed by the accused.

The inspection team left the premises at about 15.25 Hrs on 09<sup>th</sup> August 2023.

The accused committed theft of electricity U/S 135 1/b of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
