I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that Ashini Bauri was enjoying electricity unauthorisedly by reconnecting of his energy meter with electric line which was disconnected long ago due to non payment of electric energy bill

he has committed theft of electricity u/s 138 (1)(a) & 138(1)(b) of the Electricity (Amendment Act-2007)

Entered the premises of Ashini Bauri, s/o- Ganu Bauri and inspected his premises. During inspection, theft of electricity was detected u/s 138 (1) (a) & 138 (1)(b) of the Electricity (Amendment Act-2007) i.e. he was using electricity unauthorisedly by reconnecting his energy meter, having meter no. RG6 136296 & Consumer ID 201249104 of WBSEDCL with electric line being the property of a licensee when the said electric line has been disconnected .

From the above arrangement, he was using the following electrical equipments:

- 2) Color TV - 01 no
- 3) LED Bulb - 05 nos

Out of which, I seized the following electrical items:

The accused person has committed an offence u/s 138(1) (a) and 138 (1) (b) of the Electricity Act-2003 (Amendment Act-2007).
