Sub : Prayer for lodging FIR against accd. Sanjay Bauri @ Sadhan (36 yrs) S/O - Lt. Bhakta Bauri @ Bhaktu of B.C.W. Colony, PS-Santaldih Dist- Purulia, U/S 46A (c) B.E. Act 1909.

Sir,

In producing herewith arrested accused Sanjay Bauri @ Sadhan (36 yrs) S/O - Lt. Bhakta Bauri @ Bhaktu of B.C.W. Colony, PS-Santaldih Dist- Purulia, along with 09 bottles seized country spirit styled as "DIL KHUSH" 600 ml in each bottle and 12 bottles seized country spirit styled as "DIL SE" 600 ml in each bottle. I beg to state that today i.e on 21.08.2023 at 18.45 hrs acting on a tip off I along with force had been to the house of Sanjay Bauri @ Sadhan (36 yrs) S/O - Lt. Bhakta Bauri @ Bhaktu of B.C.W. Colony, PS-Santaldih Dist- Purulia. This refers to Santaldih I/C BCW GDE No- 440 and C.C No- 1658/23 of dated 21.08.2023. I along with force held raid in the house of Sanjay Bauri @ Sadhan. Seeing police van some unknown persons coming out from the house of Sanjay Bauri @ Sadhan and fled away. However I could be able to intercept Sanjay Bauri @ Sadhan. On search found 09 bottles country spirit styled as "DIL KHUSH" 600 ml in each bottle and 12 bottles country spirit styled as "Dil Se" 600 ml in each bottle in his house. I also found approx 15 empty bottles of country spirit styled as "DIL KHUSH" scattered at the courtyard of his house. On asked he failed to produce any valid documents in respect of possessing and selling of country spirit in his house as well as he confessed his guilt. Accordingly I seized and labeled 09 bottles seized country spirit styled as "DIL KHUSH" 600 ml in each bottle and 12 bottles seized country spirit styled as "Dil Se" 600 ml in each bottle under proper seizure list in presence of witnesses duly signed by them. Out of seized bottles country spirit 01(One) bottle "DIL KHUSH" and 01 (one) bottle "Dil Se" are kept as sample. I also arrested the accd. Sanjay Bauri @ Sadhan (36 yrs) S/O - Lt. Bhakta Bauri @ Bhaktu of B.C.W. Colony, PS-Santaldih Dist- Purulia.

However the accd. Sanjay Bauri @ Sadhan committed offence U/S 46 A (c) B.E Act, 1909 for possessing and selling of country spirit in his house without any valid documents.

Therefore, I pray before you that a case may be started against accd. Sanjay Bauri @ Sadhan (36 yrs) S/O - Lt. Bhakta Bauri @ Bhaktu of B.C.W. Colony, PS-Santaldih Dist- Purulia under proper section of law.
