I Sri Prashant Kishor, S/O - Kishori Prasad, Station Manager of Telkalpara CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Sanjoy Dan S/O Anath Dan of Vill - Chakda(New collony,Rani sati mandir) PS- Tamna has committed theft of electricity under section 135(1)(A) as detailed here under.

Today, i.e. on 01.08.2023 I, Prashant Kishor (SM), along with Sri Suraj Kumbhakar JE (GR-II), & Sri Deb dulal Banerjee Sr TSH of Telkalpara CCC, WBSEDCL conducted a raid programme at village Chakda(New collony,Rani sati mandir) under Tamna P.S. When our team at about 11.05 A.M.. entered to the Domestic premises of Sanjoy Dan, we found that he was enjoying electricity dishonestly by means of direct hooking from nearest L.T.O.H line and run Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized, and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 11.25 A.M.. after completion of inspection & necessary formalities.

Sanjoy Dan S/O Anath Dan of Vill - Chakda(New collony,Rani sati mandir), PS- Tamna has committed theft of electricity under section 135(1)(A) of the Electricity(Amendment) Act-2007.
