I, Surajit Kumar Das S/o- Samir Kumar Das of Vill- Kalipur Majhpara, P.O- Karidhya, PS- Suri, Dist- Birbhum, at present posted at Tamna PS, Dist- Purulia as SI of Police producing herewith one arrested accused person namely Gangadhar Mahato (55 yrs) S/O- Lt. Damu Mahato of Vill- Simulia, P.S- Tamna, Dist- Purulia with seized articles i.e. 1). 48 (Forty-Eight) sealed Bottles of country spirit styled as BUMPER, each bottle contains 300 ml. 2). 01 (One) bottle has collected from the seized articles vide SI No-01 as sample which were seized under proper seizure list.

I beg to submit that today (01.08.2023) during my PS area evening mobile duty acting of a secret source information that one person is selling Country spirit in his dwelling home at Simulia Village under Tamna PS, so myself along with i) C/2113 Goutam Das & ii) HG/1577 Badal Mahato both of Tamna PS came to the spot at about 19:05 hrs and found that one person is selling country spirit styled as BUMPER to the others. Seeing the Police party, all customers fled way but we managed to apprehend the accused person namely Gangadhar Mahato (55 yrs) S/O- Lt. Damu Mahato of Vill- Simulia, P.S- Tamna, Dist- Purulia. On being asked he failed to produce any valid licence /documents in respect of storing and selling of country spirit styled as BUMPER. As such I seized 1). 48 (Forty-Eight) sealed Bottles of country spirit styled as BUMPER, each bottle contains 300 ml. 2). 01 (One) bottle has collected from the seized articles vide SI No-01 as sample which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Gangadhar Mahato (55 yrs) S/O- Lt. Damu Mahato of Vill- Simulia, P.S- Tamna, Dist- Purulia as per proper section of law.
