Sir,

With due regards I, Sri Nirmal Kumar Sharma S/O- Late Sugan Chand Sharma of Chabi Biri Bagan, Old Police Line, Ward No. 15, P.S.- Purulia (T), District-Purulia beg to inform you that I have some landed properties at Chakda High Way Colony, Mouza- Chakda, P.S.- Tamna, District- Purulia, by the side of proposed By-Pass Road on NH-32. In course of possession we have also raised boundary wall by the side of our properties.

Today i.e. on 06/08/2023 at about 12.30 P.M. myself along with my brother Pradip Kumar Sharma went to look after our said properties, when upon some persons namely 1) Sabyasachi Sen S/O- Ananga Mohan Sen, 2) Sujit Sen S/O- Lt. Subal Chandra Sen, 3) Moloy Sen S/O- Lt. Gunamoy Sen, 4) Goutam Sen S/O- Lt. Sudhir Kumar Sen, 5) Sadhan Sen S/O- Lt. Yasoda Prasad Sen, 6) Sanjib Sen S/O- Lt. Bansi Badan Sen, all of Uppar Nadiha, Ward No. 23, P.S.- Purulia (T), District-Purulia along with 6/7 others came before us with some Iron Rods & lathi and started to damage our boundary wall over the aforesaid property. We protested against their illegal works when upon they abused us with filthy languages & threatened us with dire consequences and also damaged the Realme C25Y mobile phone of my brother Pradip Kumar Sharma. But we raised our voice against their illegal activities when upon said persons attacked us with Iron Rod, Lathi etc. & started to assault us. Some of them also caught hold us and rest were assaulting us. We tried to escape but the said persons caught hold my body. The said persons also told each other that they would kill us so that no one will go to our said land from our side. Due to such assault myself & my brother suffered bodily injury & pain all over the body. After the incident on 06/08/2023 myself & my brother went to Chakaltore BPHC, where the attending doctor at Emergency treated us & prescribed medicines for relief. The said persons also damaged most part of the boundary walls surrounded our land causing huge monitory loss to us.

Accordingly, I request your good office to take necessary legal steps against the wrong doers for committing such illegal acts, so that we can get proper relief and oblige. This complain is drafted by me.
