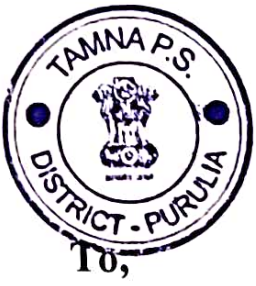

Respected Sir,

I, Hemanta Kr. Sahababu S/O- Lt. Madan Mohan Sahababu of Vill- Jabarrah, P.O- Jhapra, PS- Para, Dist- Purulia, at present posted at Tamna PS, Dist- Purulia as SI of Police producing herewith one arrested accused person namely Sk. Munna (22 yrs) S/O- Sk. Alam of Kasai Mahalla Taldanga, P.S- Purulia (T), Dist.- Purulia A/P- at Katinpara, Ward No. 22, P.S- Purulia (T), Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 20.08.2023 at about 18:35 hrs during evening mobile duty at Tamna PS area, received a secret source information that one unknown person ride with one Toto having Reg. No. WB-55A/8684 loaded with I.D Liquor came towards Simulia morh from Dulmi side and as per order of O/C Tamna PS, I SI Hemanta Kumar Sahababu of Tamna PS along with force proceed to Simulia morh under Tamna PS. When we reached near Simulia Sasan Kali Mondir at about 19:15 hrs found that one person tried to fled away after seeing Police party leaving his Toto. On hot chased I apprehended the said driver of the Toto with the help of my force near Simulia Sasan Kali Mondir under Tamna PS, Dist- Purulia. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for carrying I.D. Liquor to selling. On demand he failed to produce any valid documents in respect of said I.D. Liquor. As such I seized (i) Three white colour plastic Jericans each containing approx Eighteen (18) ltr. I.D. Liquor, (ii) Three plastic bottle each containing One (01) ltr. I.D. Liquor taken out from each of the three jericans of I.D. Liquor separately as sample. & (iii) One Toto having Reg. No. WB-55A/8684 under proper Seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed his relative regarding the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Sk. Munna (22 yrs) S/O- Sk. Alam of Kasai Mahalla Taldanga, P.S- Purulia (T), Dist.- Purulia A/P- at Katinpara, Ward No. 22, P.S- Purulia (T), Dist.- Purulia as per proper section of law.
