Most respectfully, I Durgesh Kumar Singh, s/o-late Uma Shankar Singh resident of Dhumb Dargal, Near Azad Saugh Kali Mandir, PO-RN Road, PS- Hinapur, Dist- Paschim Bardhaman W.B. 713325, Mob No. (8074145490) wish to inform your good office that being a owner of the company (D&D Enterprises), I appointed a salesman namely Abhijit Mahato, s/o- Manoranjan Mahato, Vill- Manguria, PS- Tanna, Dist- Purnia for the entire district of Purnia on 12 Nov 2022 after meeting and discussion over the phone. The goods of the said company had been supplied to him on regular basis for the sales. He made online payment of selling goods regularly till Feb 2023. After that he stopped the payment to the company. The company also stopped to supply the goods. After calculating it came to know that the exact valuation of the sending goods is Rs. 1,62,539/- (One lakh sixty two thousand five hundred thirty nine) which is still pending from the said Abhijit Mahato.
