After getting this information in the morning I visited the plantation site along with forest staffs (7 Ha State Plan QGS plantation, Year- 2021, JL no- 35, plot no 12381 of Mouza- Palpal) at about 8.00 AM on 16/09/2023, and found that near about 60 -70 healthy saplings have been cut down of that plantation site and also damage about 5 ha area of that plantation.

Therefore, you are requested to take necessary action and lodge a FIR in this regard.
