Entered the premises of Sachin Panday S/O - Dili P Panday
And inspected his/her premises. During inspection theft of electricity was detected i.e he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of W.B.S.E.D.C.L i.e U/S 135 (1) (a) was detected.

From the above arrangement he/she was using the following equipments

- 1) Ceiling Fan 6 nos 80 watt each = 480 watt.
 - 2) LED Bulb 4 nos 9 watt each = 36 watt.
 - 3) Tube light 4 nos 40 watt each = 160 watt.
 - 4) Bulb 2 nos 100 watt each = 200 watt
- used commercially purpose.
