I, ASI Ananda Mandal of Suisa OP under Baghmundi PS do hereby lodged suomoto written complaint to the effect that on 04/02/2023 at 18:45 hrsreceived a written information from MO, Pathardih BPHC namely Dr. Chandra Gourav regarding a brought dead female patient namely Sakuntala Kuiry (38), W/O-Mritunoy Kuiry of Gaghi, PS-Baghmundi, Dist-Purulia who was brought at Pathardih BPHC by her husband Mritunjoy Kuiry. Over that information Baghmundi PS U/D case No. 02/2023 dtd. 04/02/23 had been started and as per endorsement I hold surathal report over the dead body of deceased Sakuntala Kuiry at Pathardih BPHC. During surathal several nail scar mark found all over the body and blood stain found on her face. There after arranged to send the dead body of deceased Sakuntala Kuiry to Purulia Deben Mahato Govt. Medical College & Hospital through escort C/1355 Rajib Banerjee for PM examination to ascertain actual cause of death. Later on during enquiry, it was revealed that deceased Sakuntala Kuiry and her husband Mritunjoy Kuiry used to quarrel regularly with each other under the influence of liquor and at that time both assault to each other. On 04/02/23 at about 14:00 hrs both deceased Sakuntala Kuiry and her husband Mritunjoy Kuiry found lying in their room in a naked condition and intoxicated condition and on 03/02/23 night (day before incident) local public heard the nuisance in between deceased and her husband Mritunjoy Kuiry under the influence of liquor.

Collected PM report of deceased Sakuntala Kuiry (38 yrs) vide PM No. 115/2023 dtd. 05/02/23 in which Autopsy Surgeon Dr. Shobhan Roy, Assistant Professor, Department of Forensic Medicine & Toxicology, Purulia Deben Mahato Govt. Medical College & Hospital opined that "Death was due to the effects of the ante mortem injuries, homicidal in manner."

As the cause of death is due to the effects of the ante mortem injuries, homicidal in manner, So, I am submitting complaint against Mritunjoy Kuiry, S/O-Purna Chandra Kuiry of village-Gaghi, PS-Baghmundi, District-Purulia for starting a specific case and also arrange for its investigation.
