Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 (1)/(b) & (1)/(d) of the electricity Act 2003, Amendment of 2007 as stated here under.

On 29/09/2023 at 13:05 Hrs. I, Sisir Kumar Das (AE & SM Bagmundih CCC) along with Anup Mondal (JR. Engineer (E),Gr. I) and Indrajit Bouri (Sr. T.S.H.) went to make an inspection to workout upon a source information regarding theft of electricity at the domestic premises of user Ramesh Chandra Sharma, son of Lt. Omprakash Sharma, resident of Vill- Raidi ,PO- Suisa,PS- Bagmundi , Dist Purulia .

During the time of inspection at the premises 1 no of electricity meter were found having serial no DDBB35279 (Consumer id 200150157, user name- Ramesh Chandra Sharma).

It was observed that accused Ramesh Chandra Sharma has made unauthorized use of electricity under section 135 1/b & 1/d by inserting foreign material in meter serial no DDBB35279, which works as resistance to interfere with accurate or proper registration of electricity consumption and hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using 1 KW load.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected both the service lines in the same premises from pole with the help of LT Mobile Van Team and removed & seized 1 nos of damaged energy meter bearing meter no DDBB35279. Prepared seizure list and inspection report. Accused refused to sign the seizure and inspection documents.

The inspection team left the premises at about 13:20 Hrs on 29th Sept 2023.

The accused committed theft of electricity U/S 135 (1)/(b) & (1)/(d) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
