I do hereby lodge complaint empowered by enabling The Indian Electricity Act - 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Shrikanta Saren, S/o - Kharu Saren, Vill-Kapatdanga, P.O-Kuilapal, Ps - Bandwan, Dist - Purulia has committed theft of electricity U/S 135/1/a of The Electricity Act.

On 15/09/2023 about 01:10 pm, I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSEDCL, along with Anindya Sundar Paul, Office Executive, Bundwan CCC, WBSEDCL and other agency staffs visited the premises of Shrikanta Saren, S/o -, Vill-Kapatdanga P.O-Kuilapal, Ps - Bandwan, Dist - Purulia and inspect his premises. During inspection theft of electricity was detected i.e. he was using electricity dishonestly by means of DIRECT HOOKING.

From the above arrangement he was using the following electrical equipment's:

1) Water Pump - 1 Nos

Out of which I seized the following:

1) Socket with Switch

2) Service cable approx 50 mtr.

Seizure list was prepared at the site and accused person refused to sign.

The inspection team left the premises at 01:40 pm on 15/09/2023.

The accused person has committed an offence U/S 135/1/a of The Electricity Act - 2003 & subsequently Electricity (Amendment) Act - 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
