



This year the Complainant planted begun trees and also was/is in possession over the same, but on 15.07.2023 in night time at about 12:30 AM all the Accused persons came into the Complainant's land by demolishing boundaries which was raised by the Complainant with the help of axe, lathi, iron rod etc and trespass the said begun trees and when the Complainant saw from his house at that time he came to the spot and raise objection and throwing halla at that time the Accused Persons have assault to the Complainant by fist and blow and also given out threats that they take forcibly possession of the said land and also trespass the begun trees. Complainant substain loss of Rs. 16,000/- (Rupees sixteen thousand only), Complainant is very poor man, his only source of income for selling vegetables and Complainant also a Senior Citizen taking advantage they are trying to grab the property by show of force and also threatened to the Complainant that if the Complainant lodged any complaint then they will murder to the Complainant and his family members, though the Complainant has lodged complaint on 17.07.2023 by Register Post before addressed to the O/C Barabazar P.S. and the said complaint was duly received by the Barabazar Police Station and due to non taking step by the Barabazar P.S. the Complainant also lodged complaint before the SP Purulia on 18.07.2023 but till now the Concern Authority did not take any step so the Complainant file this petition against the Accused Persons for proper relief and also pray for guilty against the Accused persons.

It is prayed, that your Honour would be pleased to admit the petition and send this petition to O/C Barabazar P.S. and directing him to treat this petition as F.I.R. against the accused persons and also pass necessary order which will deemed fit and proper.
