THEFT ATTEMPT AT OUR SBI HURA BRANCH

In reference to the captioned subject We would like to inform you about the theft attempt which took place in our Branch on 02/09/2023 around 8:50 PM. A gang of robbers entered our Branch ,through backdoor after breaking the locks. Later due to the alarm system which kept on ringing loud forced the miscreants to run away leaving behind the bags with technical gadgets they brought along. Later ,When the local police and I reached the spot no one was found inside the premises. The CCTV footage shows a trespasser, with (covered face) entering the Branch and later running away.

We understand the importance of prompt action in such situation and are willing to cooperate fully with the law enforcement to provide any additional statements required to assist the investigation. Please consider this letter as my formal report.
