Sir,

I, SI- Dipak Kr Nandi along with force returned to PS with 02 (two) arrested accd. persons namely (i) Shakti Mahato (26) S/O Hemlal Mahato of Vill- Barga, PS-Barlanga, Dist-Ramgarh, JKD (rider of Black Colour Splender Pro Motor Cycle without number plate and Engine No & Chassis No tempered) and (ii) Bhola Kumar Dangi (35) S/O Sri Rohit Mahato of Vill- Barkipona, PS-Rajrappa Project, Dist-Ramgarh, JKD (rider of Blue and Yellow colour passion pro Motor Cycle having Reg. No- JH 02Q 6827) and brought under seizure (i) one Black Colour Splender Pro Motor Cycle without number plate and Engine No & Chassis No tempered loaded with approx 04 Quintal steam coal (ii) One Blue and Yellow colour passion pro Motor Cycle having Reg. No- JH 02Q 6827 loaded with approx 04 Quintal steam coal, (iii) One Balck Colour CBZ Motor Cycle having Reg. No- JH 09K 8044 loaded with approx 04 Quintal steam coal (iv) One Red colour Super Splendor Motor Cycle having Reg. No- JH 01W 7216 loaded with approx 04 Quintal steam coal & (v) One Black Colour Pulsar Motor Cycle having Reg. No- JH 02L 9829 loaded with approx 04 Quintal steam coal under proper seizure list and produced before your good self.

The fact in brief is that today (14/09/2023) I along with force namely i) C/214 Siddhartha Mandal (ii) C/955 Dilip Kr. Mandal (iii) HG/1636 Harekrishna Ghosh were performing evening mobile duty in PS area vide Jhalda P.S. GDE No- 629 Dated- 14/09/2023 in consonance with Jhalda PS CC No- 2636/23 Dated- 14/09/2023. During my evening mobile duty, at about 20:45 hrs, received a tip off that 05 (five) unauthorized Motor Cycle loaded with stolen steam coal was coming from Jharkhand side along Kenduadih Bridge Road towards Jhalda. Subsequently, I informed to you and the duty officer and asked him to note down GDE vide No 640 dated 14/09/2023. Consequently, as per your kind order I started Naka at I Loo More by placing the guardrail on the Jargo Pusti Road. Thereafter I saw the 05 (five) Motor Cycle was proceeding towards I Loo More. Consequently, we intercepted the said Motor Cycles at before Naka checking point at about 21:15 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police Party rider who was on those Motor Cycles tried to flee away. After hot chase we managed to apprehend 02 (two) of them. On being asked, the rider of the Motor Cycles disclose their identity noted in the supra. I asked the rider of the Motor Cycles to produce the valid documents in respect of the Motor Cycles as well as the loaded steam Coal. But the rider of the said Motor Cycles could not able to produce any kind of documents in respect of the Motor Cycles and the loaded steam Coal. We waited for reasonable time but none came to spot to produce any documents in respect of other 03 (three) Motor Cycles loaded with steam Coal. So it is reasoned to belief that the rider & Owner of the said Motor Cycles in cahoots with others procured the said steam coal from Jharkhand state by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo, I seized the following articles (i) one Black Colour Splender Pro Motor Cycle without number plate and Engine No & Chassis No tempered loaded with approx 04 Quintal steam coal (ii) One Blue and Yellow colour passion pro Motor Cycle having Reg. No- JH 02Q 6827 loaded with approx 04 Quintal steam coal, (iii) One Balck Colour CBZ Motor Cycle having Reg. No- JH 09K 8044 loaded with approx 04 Quintal steam coal (iv) One Red colour Super Splendor Motor Cycle having Reg. No- JH 01W 7216 loaded with approx 04 Quintal steam coal & (v) One Black Colour Pulsar Motor Cycle having Reg. No- JH 02L 9829 loaded with approx 04 Quintal steam coal


coal after preparing proper seizure list in presence of available witnesses duly signed by them and also arrested the riders namely (i) Shakti Mahato (26) S/O Hemlal Mahato of Vill- Barga, PS- Barlanga, Dist- Ramgarh, JKD and (ii) Bhola Kumar Dangi (35) S/O Sri Rohit Mahato of Vill- Barkipona, PS-Rajrappa Project, Dist-Ramgarh, JKD after informing the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said seizure articles to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the accd. persons namely (i) Shakti Mahato (26) S/O Hemlal Mahato of Vill- Barga, PS-Barlanga, Dist- Ramgarh, JKD (rider of Black Colour Splender Pro Motor Cycle without number plate and Engine No & Chassis No tempered) and (ii) Bhola Kumar Dangi (35) S/O Sri Rohit Mahato of Vill- Barkipona, PS-Rajrappa Project, Dist-Ramgarh, JKD (rider of Blue and Yellow colour passion pro Motor Cycle having Reg. No- JH 02Q 6827) and (iii) Owner of Black Colour Splender Pro Motor Cycle without number plate and Engine No & Chassis No tempered & (iv) Owner of Blue and Yellow colour passion pro Motor Cycle having Reg. No- JH 02Q 6827 and (v) Rider and owner of One Balck Colour CBZ Motor Cycle having Reg. No- JH 09K 8044 (vi) Rider and owner of One Red colour Super Splendor Motor Cycle having Reg. No- JH 01W 7216 & (vii) Rider and owner of One Black Colour Pulsar Motor Cycle having Reg. No- JH 02L 9829 and other persons as they committed offence U/S- 379/411/414/120B of the IPC.
