Sir,

In producing herewith 01 (One) arrested accused person namely Debu Bagti (20) S/O Bauri Bagti of Jhalda Dompara, Ward No-8, PS-Jhalda, Dist -Purulia brought under arrest along with seized articles as per seizer list i.e. 20 (Twenty) bottles seal of Dil Khush of India made Liquor each containing 600 ml. in a plastic bag under proper seizure list with label.

I SI Alope Chattaraj of Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that today (22/09/2023) myself along with (i) C/1284 Pratapaditya Majhi (ii) C/240 Manoranjan Bagti and (iii) NVF/843 Bibekananda Mahato (iv) HG/1772 Fatik Ch. Kumar all of Jhalda PS were performing anti crime evening mobile duty (This refers to Jhalda PS CC No. 2746/23 dated 22/09/2023 and GDE No. 994 dated 22/09/2023. During evening mobile duty at about 20:25 hrs I received a credible source information that the above noted accused person selling ID Liquor from residential house situated at Jhalda Dompara, Ward No-8, PS-Jhalda, Dist-Purulia. On receipt such information I immediately informed the matter to you and as per your kind direction I along with force proceeded to work out the information. We reached at Jhalda Dompara, Ward No-8, PS-Jhalda, Dist-Purulia at about 21:05 hours and held raid in the house of Debu Bagti and found that the accused person namely Debu Bagti (20) S/O Bauri Bagti of Jhalda Dompara, Ward No-8, PS-Jhalda, Dist-Purulia selling ID Liquor from his house. Seeing the Police party the buyers are fled away. On searched 20 (Twenty) bottles seal of Dil Khush of India made Liquor each containing 600 ml. in a plastic bag was found there. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the local people illegally. So, finding no any other alternative I seized the above noted articles from the possession of the accused person and labelled, duly singed by the accused person & witnesses in which 600 ML of Dil Khush of India made Liquor one seal bottle from mother sample was kept as sample with label. During interrogation he confessed his guilt as such I arrested him after observing all the formalities as per law issuing memo of arrest as the accused person are liable for prosecution U/S-46A (c) of the Bengal Excise Act. 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Debu Bagti (20) S/O Bauri Bagti of Jhalda Dompara, Ward No-8, PS-Jhalda, Dist-Purulia U/S- 46A (c) of the Bengal Excise Act. 1909.
