Sir,

I am writing to formally request that you take cognizance of a serious incident that occurred on 17.09.2023 at approximately 20:30 hrs and treat it as a First Information Report (FIR). The incident in question involves the physical assault on Mr Buddheswar Kumar S/O: Late Sukdev Kumar , Mr Manindranath Mahato S/O: Biswanath Mahato , Shambunath Mahato S/O: Shaktipada Mahato all are member of the Jhalda HT maintenance team Of Jhalda 33/11 KV Substation, by Mr. Sajan Bhagat (S/O: Jiten Bhagat) and Mr. Chiku Bhagat (S/O: Tapu Bhagat) with their unruly mob, all are residents of Vill-Koradih, P.O-Torang, P.S-Jhalda, Dist-Purulia.

On the aforementioned date and time, a breakdown of the 11 KV Ilu feeder occurred due to bad weather conditions. Following this incident, the HT maintenance team was dispatched to conduct patrolling and carry out necessary restoration work on the affected power lines. Unfortunately, while they were engaged in their duties, they encountered an obstacle created by Mr. Sajan Bhagat and Mr. Chiku Bhagat with their unruly mob in the vicinity of Patharadhi.

Mr. Sajan Bhagat and Mr. Chiku Bhagat subjected Mr Buddheswar Kumar, Mr Manindranath Mahato and Shambunath Mahato to physical assault, causing harm and distress to them.

Given the gravity of the situation and the need for a prompt action, we kindly request that you treat this incident as an FIR. We trust that you will take the necessary legal actions to ensure that justice is served and those responsible for this assault is held accountable under the law.

Your prompt attention to this matter is highly appreciated. We are confident in the capabilities of the Jhalda Police Station to handle this case effectively and bring the culprits to justice.

Thank you for your cooperation and commitment to upholding the law and ensuring the safety of our community.
