Respected Sir,

In producing herewith 01 (one) arrested accused person namely Dinesh Mahato @ Nayan Mahato (23 yrs) S/o-Dhirendranath Mahato of Vill-Sardaha, PS-Pindrajora, Dist-Bokaro State-Jharkhand along with seized Mahendra B-275 DI Tractor Red Colour having Regd. No-JH09AS-4870 with trolley loaded with sand (100 CFT approx) under proper seizure list, I beg to submit that today (08/09/2023) I ASI Swapan Mandal along with (1) C/-1234 Mantulal Mandal (2) NVF/-803 Ankur Ch Mahato both of Joypur P.S were performing Special Mobile duty vide Joypur PS CC No-2192/23 Date-08/09/2023. During my mobile duty at about 12:05 hrs received a credible source information that one tractor loaded with sand was coming from Hetkahan side, I along with force reached at Nabakunja more under Joypur PS and found that a Tractor having Regd. No- JH09AS-4870 loaded with sand was coming from Hetkahan village side. On seeing the Police party at Nabakunja more, the driver of the said Tractor were trying to fled away. But after a hot chase, we could able to detain the driver of said tractor having Regd. No- JH09AS-4870. On integration he made incoherent statement at different time. He disclosed his identity as Dinesh Mahato @ Nayan Mahato. I asked the driver Dinesh Mahato @ Nayan Mahato to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. I interrogated him thoroughly. During interrogation, he admit that he is dealing with illegal sand lifting from Kangsabati riverbed and transporting the sand. The driver also failed to produce any paper in respect of the Tractor. Hence, I seized the one Mahendra B-275 DI Tractor Red Colour having Regd. No-JH09AS-4870 with trolley loaded with sand (100 CFT approx) in between 12:35 hrs to 12:45 hrs under proper seizure list in presence of available witnesses duly signed by them and I arrested Dinesh Mahato @ Nayan Mahato (23 yrs) S/o-Dhirendranath Mahato of Vill-Sardaha, PS-Pindrajora, Dist-Bokaro State-Jharkhand. After observing all formalities & disclosed him about the ground of arrest. I brought the said Tractor to Joypur P.S. As such there is every reason to believe that the driver and owner of the tractor is dealing with sand illegally and transporting with ill motive without any valid documents and also violating the order notification vide Memo No-MDTC/SAND/02/Part-I/1602 Date-21/06/2023 regarding ban of sand lifting from riverbed.

Hence, they are liable for offence punishable U/S-188/379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against Dinesh Mahato @ Nayan Mahato (23 yrs) S/o-Dhirendranath Mahato of Vill-Sardaha, PS-Pindrajora, Dist-Bokaro State-Jharkhand may kindly be started and arrange for its investigation.
