In producing herewith the arrested accused persons namely (1) Om Prakash Prasad @ Guddu (39 yrs) S/o-Late Kapil Deb Prasad of Bhawra 12 number, PO- Bhawra PS-Jorapokhar Dist-Dhanbad State-Jharkhand (2) Dablu Kr Singh (36 yrs) S/o-Sri Digambar Singh of Vill-Seerma PO-Shailhara PS-Chouparan Dist-Hazaribag State-Jharkhand along with seized articles viz (i) One white & blue coloured nylon bag, marked as Exhibit - "A" (ii) One white colour plastic Jaricane along with red coloured cap containing 12540 grams (including Jaricane) of light red coloured codeine like mixture, marked as Exhibit - 'B' (rest mother sample after taken out Exhibit Mark "C", "D" & "E"), (iii) 100 grams (including bottle) of codeine like mixture as test sample marked as Exhibit - "C" (iv) 100 grams (including bottle) of codeine like mixture as security sample marked as Exhibit - "D". (v) 100 grams (including bottle) of codeine like mixture as security sample marked as Exhibit - "E". Exhibit mark C, D & E were collected from mother sample which was 12840 grams (including Jaricane) of light red coloured codeine like mixture, all Exhibits are in properly sealed and labelled condition (vi) One 'itel' mobile phone bearing IMEI no.355750326428025 & another IMEI no. 355750326428033 and SIM no. 9635465195 marked as Exhibit - "F" (vii) One black coloured Scorpio bearing Regd. No-JH09BG-8257 under proper seizure list.

I, S.I. Sanjay Diger, in-charge Baglata Investigation Centre under Joypur PS do hereby lodge a written complaint against the aforesaid accused persons to the effect that on 16/09/2023 at 11.35 hrs myself along with C/-1190 Swapan Gorai, C/-120 Sandip Kumar & C/-1389 Debnath Roy and one Videographer left Baglata I.C. to perform naka duty vide CC No-1505 Dated-16/09/2023. We were engaged in Naka checking duty at Gopalpur More (Inter State border of West Bengal & Jharkhand), Vill-Ghaghra, under Joypur PS Dist-Purulia and at 12.05 hrs I found the one black color vehicle (Scorpio) were coming from Jharkhand side towards Ghaghra village under Joypur PS. On seeing the Naka Checking party they stopped the vehicle and tried to flee way. Then myself along with force rush to the vehicle and intercepted it and found the above noted 02 persons who were sitting into the vehicle, one of them was at driver's sit. I detained them and searched the car with videography and found One white & blue coloured nylon bag containing one white colour plastic Jaricane along with red coloured cap containing light red coloured like mixture. I asked the both of detained persons, but they replied incoherent regarding their identity as well as the substance (light red coloured like mixture which was found in their possession. I told them that I suspected that they were carrying codeine like mixture or any narcotic substance into that jaricane. I accordingly informed the matter to I.C. Joypur PS through his mobile phone at 12.26 hrs about the fact and requested him to arrange for a magistrate, if possible, for conducting search at the spot and requested to send Electronic weighing balance, narcotic kit box and investigation box containing print blank arrest memo, seizure list inventory list etc. I then tried to call 2 (two) local persons as witness but I did not find any persons there. At 12.55 hrs, Sri Liton Rakshit, I.C. Joypur Police Station, being a Gazetted officer reached at the spot as no Magistrate or other Gazetted officer was available and disclosed his identity as Gazetted officer to the above noted detainee. In presence of him I asked detainee further, then they disclosed their identity as noted above. I offered the detainee whether they wanted to be searched by a

officer. In this respect I issued them a written notice duly acknowledged by the detainee. In reply in writing, they both stated that they had no objection if they were searched by any Police personnel on that notice. We also offered them to search our persons and they searched all Police personnel but nothing objectionable was found. Hence "NIL" search list was prepared. I prepared inventory of articles possessed by the IC Joypur Sir, 13.25 hrs. Then as per order of Sri Liton Rakshit I.C. Joypur Police Station and in front of the above noted Police witnesses I recovered said nylon carrying bag from the vehicle of detained persons (1) Om Prakash Prasad @ Guddu (2) Dablu Kr Singh, which was containing white coloured jaricane loaded with codeine like mixture. I got it weight by weighing machine and the weight is of codeine like mixture 12840 grams (including jaricane). On being asked they told that they came there to sell codeine like mixture. On demand they failed to produce any valid license or papers in support of their possession of illegal codeine like mixture. As per order of IC, Joypur P.S., I seized the articles i.e. (i) One white & blue coloured nylon bag, marked as Exhibit - "A" (ii) One white colour plastic Jaricane along with red coloured cap containing 12540 grams (including Jaricane) of light red coloured codeine like mixture, marked as Exhibit - 'B' (rest mother sample after taken out Exhibit Mark "C", "D" & "E"), (iii) 100 grams (including bottle) of codeine like mixture as rest sample marked as Exhibit - "C" (iv) 100 grams (including bottle) of codeine like mixture as security sample marked as Exhibit - "D", (v) 100 grams (including bottle) of codeine like mixture as security sample marked as Exhibit - "E", Exhibit mark C, D & E were collected from mother sample which was 12840 grams (including Jaricane) of light red coloured codeine like mixture, all Exhibits are in properly sealed and labelled condition (vi) One 'itel' mobile phone bearing IMEI no.355750326428025 & another IMEI no. 355750326428033 and SIM no. 9635465195 marked as Exhibit - "F" (vii) One black coloured Scorpio bearing Regd. No-JH09BG-8257 under proper seizure list. I sealed and labelled the Exhibits in presence of IC, Joypur PS, duly signed by them i.e. Police witnesses, accused persons and IC Joypur PS too. The seizure was made on 16/09/2023 in between 13.35 hrs and 15.15 hrs. Then I arrested the accused (1) Om Prakash Prasad @ Guddu (39 yrs) S/o-Late Kapil Deb Prasad of Bhawra 12 number, PO- Bhawra PS-Jorapokhar Dist-Dhanbad State-Jharkhand (2) Dablu Kr Singh (36 yrs) S/o-Sri Digambar Singh of Vill-Seerma PO-Shailhara PS-Chouparan Dist-Hazaribag State-Jharkhand, on 16/09/2023 in between 15.25 hrs & 15.30 hrs., after maintaining all formalities of arrest. Inventory of NDPS articles were also done at 15.45 hrs.

I, therefore, pray, that a case U/S-21(C) NDPS Act may kindly be started against the accused persons (1) Om Prakash Prasad @ Guddu (39 yrs) S/o-Late Kapil Deb Prasad of Bhawra 12 number, PO- Bhawra PS-Jorapokhar Dist-Dhanbad State-Jharkhand (2) Dablu Kr Singh (36 yrs) S/o-Sri Digambar Singh of Vill-Seerma PO-Shailhara PS-Chouparan Dist-Hazaribag State-Jharkhand and arrangement may kindly be made for its investigation.
