
In the matter of a humble complainant on behalf of the complainant:-

Most Respectfully Sheweth:-

 That, Complainant happens to be a local resident of Village+P.O-Chaitandih, P.S- Joypur, District- Purulia.







- 2. That, on 02/07/2023 at about 8.30 AM in the morning as usual when the Complainant and her husband were on the field busy with their agricultural operations at that time suddenly the aforesaid persons namely Santosh Bauri and Ramesh Bauri along with unknown miscreants illegally and unlawfully trespassed into the Land of the Complainant forcibly without having any right and began to tear and damage their grown Crops and when they raised objection at that time the aforesaid Santosh Bauri and Ramesh Bauri and other miscreants accompanied them started to use slang languages towards us and gave out threats that they will disposes the Complaint and her husband forcibly and if necessary they kill all of Complaint and her husband and if Complaint and her husband dare to put their steps in the Plot then they will kill Complaint and her husband..
- 3. That due to the constant persuasion of the Complaint and her husband the aforesaid persons stopped damaging our Crops but the aforesaid Santosh Bauri and Ramesh Bauri thereafter came near the Complainant and tried to touch her private parts and began to molest her but the Complainant and her husband anyhow protested but Santosh Bauri and Ramesh Bauri taking advantage of their numbers pushed her husband with heavy force for which her husband fell down in the Ground and sustained injury but the Complainant shouted a lot and due to her yelling the aforesaid Santosh Bauri and Ramesh Bauri and others managed to fled away from the spot. Co-Villagers witnessed the incident.
- 4. That the aforesaid Santosh Bauri and Ramesh Bauri are very dangerous and desperate in nature and they are always armed with weapons and they very adamant to commit the mischief but it is not possible for Complaint and her husband to defend themselves from the highhanded activities of the aforesaid Santosh Bauri and Ramesh Bauri and if the Police Department do not lay their helping hand in favor of the Complaint and her husband then they will be certainly lifeless and landless.
- 5. That as the complainant was busy in treatment of her husband hence delay in lodging the Complaint took place.
- 6. That the Complainant went to the Joypur Police Station to lodge a complaint against the accused persons but no initiative has been taken by the P.S concerned, later the matter has been informed to the O.C Joypur P.S in writing, through registered post on 13/07/2023 delivered to the Police Station on 17/07/2023 and he is well posted with the matter, but for reasons unknown no legal action or F.I.R has been lodged against the accused persons.







- 7. That the matter has been informed in writing to the Superintendent of Police, Purulia on 07/08/2023 but till date no legal initiatives has been taken by the Office concerned hence the Complainant had no other alternative but to approach before the Ld. Court of Law to file this petition praying for taking necessary action against the accused persons and others who have committed illegalities against me.
- 8. That, proper Police investigation should be taken up by treating this complaint as F.I.R and action should be taken against the accused persons and others who are associated with them as per Law for the Interest of Justice.
- 9. That, as Joypur Police Station in spite of getting specific information/ complaint from the complaint has not instituted any F.I.R, let this complaint be forwarded to O.C Joypur Police Station for treating the same as F.I.R and for undertaking investigation.
- 10. That as required all the formalities of Lodging Complain U/S- 154 Cr.P.C, U/S- 154(3) Cr.P.Code has duly been complied with by the complainant.
- 11. That the Photostat copies of the application send to the O.C Joypur Police Station, its postal receipt, track report, application submitted before the Superintendent of Police, Purulia are attached herewith this petition with a separate firisti.

Hence it is prayed that Your Honour may graciously be pleased to pass appropriate Orders U/S- 156(3) Cr.P.C by directing the Officer-In-Charge Joypur Police Station to treat the complaint as F.I.R and undertake proper investigation.
