Sir,

In producing here with 01 (One) arrested accused person namely Rampada Gorain (44 yrs) S/o-Prafullya Gorain of Vill+PO-Damru PS-Joypur Dist-Purulia along with seized articles i.e. 01 (one) Motor Cycle without registration loaded with approx 7 quintal steam coal as per seizure list and submitting a written complaint against the motor cycle rider, to the effect that today i.e. 12/09/2023 myself along with C/-120 Sandip Kumar, NVF/-0901 Sibeswar Kuiry both of Baglata IC under Joypur PS Dist-Purulia were performing Special Mobile duty at PS area vide CC No-1483/23 Dated-12/09/2023. During mobile duty at about 12:35 hrs received credible source information that one Motor Cycle without registration loaded steam coal was coming from Joridih PS area under Jharkhand State towards Pundag side under Joypur PS. After receiving source information, I informed the matter to IC Joypur PS and as per your kind direction we proceeded to work out the information. We stop the Motor Cycle loaded with coal and found that approx 07 quintal steam coal with his motor cycle near Damru village more. On seeing Police persons, he tried to fled away, after hot chase we able to apprehended the above noted person. On being asked he disclosed his name and address as noted above. On interrogation he stated that he will sell illegal coal to the local people at Pundag Bazar area under Joypur PS. On demand he failed to produce any valid papers in respect of possessing selling of steam coal. So, it is reasonable to believe that the Motorcycle rider collected the said coal either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the Motorcycle transporting steam coal illegally. So, I seized the same under proper seizure list in between 12:55 hrs to 13:15 hrs & label duly signed by witnesses after taking sample of 01 kg steam coal. During further interrogation he confessed his guilt as such I arrested him today i.e. 12/09/2023 at 13:25 hrs as the accused person is liable for prosecution U/S-379/411/414 IPC.

So, I therefore pray before you, kindly lodge an FIR against the rider of the Motor Cycle without registration number namely Rampada Gorain (44 yrs) S/o-Prafullya Gorain of Vill+PO-Damru PS-Joypur Dist-Purulia as per law and arrange for its investigation.
