I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Rita Mahali, W/O-Santosh Mahali of Vill- Mayadih, P.S- Joypur , Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 28.09.2023 at about 01.30 P.M I, Sri Rabindranath Das, AE & Station Manager, Joypur CCC along with 01. Raushan Kumar, JE(E) Gr-II, Joypur CCC ,02. Ganesh Mahato, Gr-I TSH, Joypur CCC, and 03. Shibaram Mahato, Gr-I TSH entered the premises of Rita Mahali, W/O-Santosh Mahali of Vill- Mayadih, P.S- Joypur , Dist- Purulia and found that Rita Mahali, W/O-Santosh Mahali was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through Green & white colour PVC 1.5 sq mm Chinese wire 2 core with hooking arrangement (approx 17 mtr) by means direct hooking to her domestic premises and connected load found 0.220 KW. As that Rita Mahali, W/O-Santosh Mahali committed theft of electric power, I seized the following articles after preparing the seizer list in presence of 01. Raushan Kumar, JE(E) Gr-II, Joypur CCC ,02. Ganesh Mahato, Gr-I TSH, and 03. Shibaram Mahato, Gr-I TSH Joypur CCC. The inspection team left the premises at 01.50 P.M.
