I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Nagan Kuiry, S/O-Late Dibakar Kuiry of Vill & PO - Sidhi, Tola- Jelladih, P.S- Joypur , Dist- Purulia has committed theft of electricity U/S 138 (b) of electricity act 2003 subsequently amendment act 2007.

On 28.09.2023 at about 02.15 P.M I, Sri Rabindranath Das, AE & Station Manager, Joypur CCC along with 01. Raushan Kumar, JE(E) Gr-II, Joypur CCC , 02. Ganesh Mahato, Gr-I TSH, Joypur CCC and 03. Shibaram Mahato, Gr-I TSH, Joypur CCC entered the premises of Nagan Kuiry, S/O-Late Dibakar Kuiry of Vill & PO - Sidhi, Tola- Jelladih, P.S- Joypur , Dist- Purulia and found that Nagan Kuiry, S/O-Late Dibakar Kuiry was enjoying electricity unauthorizedly connecting disconnected service line and enjoying power from the LTOH line of WBSEDCL. The connection of Nagan Kuiry with meter No. B2592087 was disconnected on 10.12.2019 due to non payment of energy bill. During inspection it is found that Nagan Kuiry reconnects his service connection with LTOH line unauthorisely and enjoying power in his premises. Contractual load of his connection (Consumer ID: 242107864) is 0.47 kVA. The connection is disconnected from LTOH line with final meter reading 002915. The inspection team left the premises at 02.30 P.M.

Nagan Kuiry, S/O-Late Dibakar Kuiry of Vill & PO - Sidhi, Tola- Jelladih, P.S- Joypur , Dist- Purulia has committed an offence U/S 138 (b) Electricity Act, 2003 (Amendment Act, 2007), so you are requested to take cognizance of this complaint and treat it as F.I.R.
